

## Quick Visa Check for U.S. Citizens

E-Visas, ETA's, Visas on Arrival and No visa required, you must hold the following:

- A passport containing 2 blank visa pages that is valid for 6 months past the date that you will enter the country.
- Proof of sufficient funds.
- Proof of onward or return flights.
- All documents required for your next destination.

Note: It may be possible to obtain the required visa upon arrival at some of these destinations Listed Below. Significant restrictions often apply and requirements for entry vary. Check with the local consulate for details. Inquire with your airline if boarding is allowed without a visa. Immigration officials at the destination country can refuse entry to anyone for any reason. To minimize risk of being refused entry and to avoid excessive waiting for an on-arrival visa to be issued. We at Sam Talwar recommend that travelers obtain all visas prior to departure.
