

Travel Visas

A passport containing at least 2 blank visa pages that is valid 6 months past the date that you will enter the country.

Proof of sufficient funds.

Proof of onward or return flights.

All documents required for your next destination.

Note: The type of visa you will need is related to the purpose of your travel as defined by the immigration law of each individual country.

Note: Significant restrictions often apply and requirements for entry vary. Check with the local consulate for details. Inquire with your airline if boarding is allowed without a visa. Immigration officials at the destination country can refuse entry to anyone for any reason. To minimize risk of being refused entry and to avoid excessive waiting for an on-arrival visa to be issued. We at Sam Talwar recommend that travelers obtain all visas prior to International Departures.
