Terms and Conditions

1) Securing the Booking and Deposit

- A deposit of 50% of the total estimated event cost is required to secure and confirm any event booking.
- The event date is not considered secured until the deposit has been received and acknowledged by the resort.

2) Deposit Refund Policy

- The 50% deposit is refundable up to three (3) months prior to the event date.
- Within three (3) months of the event date, the deposit becomes non-refundable.
- At the resort's discretion, a resort credit may be offered in lieu of a refund.
 - Any resort credit issued will be valid for up to twelve (12) months and may be applied toward eligible resort services.

3) Service Fee and Taxes

- All event invoices are subject to a 10% service fee, calculated on the pre-tax subtotal.
- Applicable taxes will be added in accordance with local requirements.

4) Final Payment Deadline

- The full remaining balance must be paid no later than four (4) days prior to the event date.
- The resort reserves the right to withhold final preparations, confirmations, or setup if the balance is not paid by the deadline.

5) Final Guest Numbers and Catering Guarantee

- Final food and beverage guest numbers must be submitted before the final payment is made, and will be used as the guaranteed minimum for preparation and billing.
- The resort cannot increase guest numbers unless:
 - a revised invoice reflecting the increase has been issued, and
 - payment for the increased amount has been received in advance.
- If payment for an increase is not received, the resort will prepare and set up only for the number of guests already paid for.

6) Reductions After Payment

- If guest numbers decrease after payment has been made, no refund or credit will be issued.
- (The resort will prepare based on the final paid/guaranteed number.)

7) Payment Method and Payee

- All checks must be made payable to: Rosalie Holdings Ltd.
- The resort may accept other payment methods as advised at the time of invoicing.

8) Accommodation for Event Bookings

- All rooms associated with event bookings must adhere to the resort's standard check-in and check-out policies.
- Any unauthorized late check-out, early check-in, or increase in room occupancy beyond the confirmed reservation will result in additional charges in accordance with the resort's room and occupancy policies.

9) Resort Discretion and Compliance

- The resort reserves the right to apply these Terms and Conditions to ensure smooth operations and service delivery for all guests and events.
