These prices are effective as of July 1, 2026 but are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain in writing on the statement we provide describing the funeral services and merchandise you selected.

This list does not include prices for certain items or services you select such as: cemetery charges, flowers, newspaper notices and clergy offerings. The estimated or actual prices for these items or services will be shown on the statement describing the funeral services and merchandise you selected.

SERVICES OF FUNERAL DIRECTOR & STAFF

Our professional service charge includes, but is not limited to counseling, availability on a 24 hours basis, consulting with family and clergy, assistance of staff in all necessary phases of arranging, obtaining, preparing and filing of necessary notices, authorizations, consents, certificates and permits. Coordinating with those providing other portions of the funeral, e.g. cemetery, crematory; and assistance to the family following the funeral and the final disposition.

Included in this charge are overhead expenses relative to our facility such as: insurance, maintenance, utility costs and secretarial, administrative, equipment and inventory expenses. \$2395.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial and forwarding or receiving remains.

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming is necessary; however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. Charges include use of the preparation room.

FORWARDING OF REMAINS TO ANOTHER

FUNERAL HOME OR MORTUARY \$2395.00

This charge includes removal of remains, services of staff, embalming, receptacle for body, necessary authorization, local transportation to airport or railroad. It does not include the services of the staff or the use of facilities for any visitation and or rites or ceremonies prior to forwarding of the body. A fee of \$3.50 per mile plus toll charges will be charged for transporting remains beyond a twenty (20) mile radius of the funeral home.

RECEIVING REMAINS FROM ANOTHER

FUNERAL HOME OR MORTUARY \$2195.00

This charge includes temporary (48 hrs.) shelter of the remains, transportation of remains to cemetery or crematory and required services of the staff. It does not include the services of the staff or the use of facilities for viewing or funeral rites or ceremonies. A fee of \$3.50 per mile plus toll charges will be charged for transporting remains beyond a twenty (20) mile radius of the funeral home. Does not include transportation from airport or other funeral home.

IMMEDIATE BURIALS

Price Range \$3315.00 to \$4,410.00

Our charge for immediate burial (with no attendant rites or ceremonies includes:

- Removal and shelter of the remains
- Local transportation to cemetery
- Necessary services of staff and authorizations

Should you choose immediate burial, the following selections are available:

Immediate burial without casket-cost of casket additional \$3315.00
Immediate burial with Omega 1 metal casket \$4410.00
Immediate burial with casket provided by family \$3315.00

DIRECT CREMATION PLUS CASH ADVANCES

Price Range \$2300.00 to \$2600.00

Our charge for a direct cremation (with no attendant rites or ceremonies) \$2300.00

This charge includes:

- One man removal and shelter of remains (including two days of refrigeration). Cremains will be returned in a wrapped cardboard box or black plastic container with cremains in a plastic bag inside either temporary container.
- Arrangement conference and filing of death certificate
- Necessary services of staff and permits
- Obituary and or video service \$125.00

CASH ADVANCES-crematory charges, ME permits, etc.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of Materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of either cardboard or fiber/flakeboard.

Should you choose direct cremation, the following selections are available: **plus cash advances**

Direct cremation with heavy cardboard container \$2400.00
Direct cremation with rigid container provided by family \$2300.00
Direct cremation with plywood base container \$2600.00

Note:

Pennsylvania Rules and Regulations Number 13.202 6(i), require that any human remains held twenty-four (24) hours beyond death shall be embalmed or sealed in a container that will not allow fumes or odors to escape or kept under refrigeration. If this does not conflict with a religious belief or medical examination.
