This charge includes basic services of funeral director and staff, local transfer of remains from place of death directly to crematory, death certificate procurement, cremation process. This charge does not include the use of facilities and staff for visitation, viewing, or ceremony (public or private) prior to cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are unfinished and finished fiberboard boxes, as well as solid hardwood and veneer alternative cremation containers.
