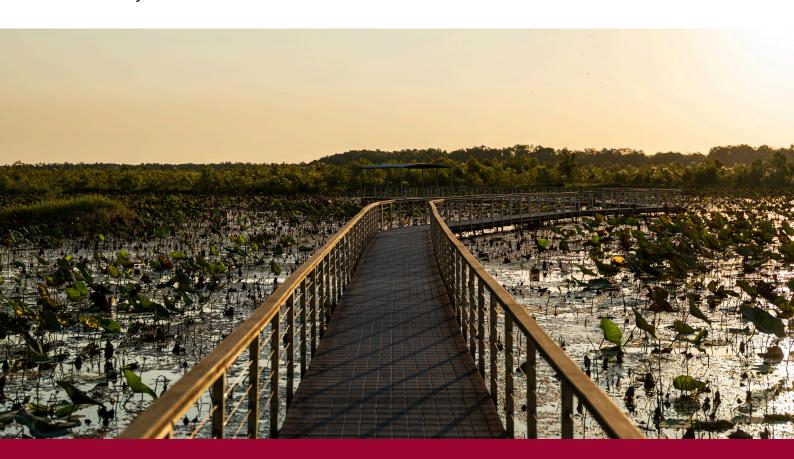

We pay our respects to Aboriginal and Torres Strait Islander cultures and to Elders past and present.


Acknowledgement of Artwork

AADANT sincerely thanks Yvonne Odegaard, for sharing her artwork "Gulumoerrgin Gutitmidjindawa – Healing Country" (Larrakia Saltwater Healing Country).

This painting reflects Yvonne's deep spiritual connection to Larrakia Land and Sea, guided by Songlines, Totems, and ancestral wisdom. The Sea Eagle (Boetemba) and Saltwater Crocodile (Danggalaba) symbolise protection, respect and the wellbeing of Larrakia people, while the circles represent healing centres where families can seek pathways to recovery from alcohol, drugs and smoking.

The yellow kapok flowers signal Gurrulwa Guligi – Big Wind time, a season of ceremony, renewal and reconnection to Country, reminding us of the strength and healing that culture brings. Yvonne's artwork also tells the broader story of the impacts of alcohol and other drugs on Aboriginal lives, families, and culture and the ongoing importance of healing through connection and respect.

AADANT is honoured to share this work as a reminder of resilience, culture, and the power of Country in supporting community wellbeing.

Executive Officer Report

I am pleased to share a snapshot of AADANT's achievements over the past year marked by strong advocacy, workforce development, sector coordination dedicated member engagement. Despite workforce and service pressures, our sector has continued to show remarkable strength, innovation and commitment to community outcomes. Guided by AADANT's principles of leadership, excellence, collaboration, accountability and cultural responsiveness, we translated these values into tangible action across urban, rural and remote Northern Territory contexts.

We acknowledge the support and funding of the Australian Government Department of Health, Disability and Ageing, the Northern Territory Department of Health and NT PHN.

Over the year, AADANT delivered more than 25 training programs across the Territory, building capability in harm reduction, youth AOD, online Sobering Up Shelter practice and neurocognitive conditions such as FASD and TBI. AADANT is currently developing Dual Diagnosis training for delivery in 2025–2026, developed by 360Edge and delivered in partnership with AADANT and the NT Mental Health Coalition, funded by NT PHN and supported by a robust evaluation framework.

Sector data collection capability was further strengthened through an AODTS-NMDS webinar and the reactivation of our Community of Practice.

Our 2025 Conference, Voices of Change: Leading the Way, brought together over 120 attendees and 47 presenters to highlight culturally led practice, decolonised health approaches and the intersection of housing and health. My sincere thanks to the Conference Steering Committee for their guidance and to our sponsors for their generous support. The NT AOD Awards followed, celebrating excellence in harm reduction, youth work, cultural safety and treatment innovation.

Following our May conference, we partnered with Flinders University to film several member organisations in Darwin and Alice showcasing their Springs, work opportunities for student placements. These videos have now been finalised by the Flinders media team and will be used to promote social work placements across our member services. We will continue to support and promote placements for social work, psychology, occupational therapy, and mental health nursing students. We extend members our thanks to the who participated and helped highlight the value of AOD placements in the NT.

Executive Officer Report

AADANT continued to play an influential role in alcohol and other drug policy, advocating for harm-minimisation measures such as Minimum Unit Pricing, and contributing to national submissions on youth justice and AOD health impacts. We strengthened collaboration with AMSANT, NTCOSS, NT PHN and ACCHOs, driving integrated approaches across AOD, mental health and social services.

Professor James Smith, AADANT Vice Chairperson, continues to provide outstanding leadership in alcohol harm minimisation research, directly informing key Northern Territory alcohol policies and building research capacity in Aboriginal and Islander **Torres** Strait health. contribution was recognised through the 2024 Sax Institute Research Action Award.

Looking ahead, AADANT will consolidate Dual Diagnosis training, complete the NT AOD Case Management Toolkit and deepen partnerships to address system bottlenecks, especially in our remote communities.

We are preparing for potential 2026 funding challenges through developing sustainability strategies and train-the-trainer models to ensure long-term capability across the Territory.

Thank you to our Board, members, staff, and funders ACCHOs especially the Northern Territory Government Department of Health, the Australian Government Department of Health, Disability and Ageing and NT PHN for your continued support. Together, we building momentum grounded in evidence, culture and community.

Capacity Building & Engagement Coordinator Report

The role of Capacity Building and Engagement Coordinator is focused on helping AADANT's member organisations improve their ability to deliver high-quality, evidence-based services in the AOD sector.

This role is vital to strengthening the capabilities of our members to deliver high quality treatment and support to people who experience alcohol and other drug related harm. The Coordinator drives this capacity-building designing by delivering targeted training programs, workshops, AADANT Conference, monthly webinars and other professional development opportunities tailored to the needs of the AOD workforce.

Key Responsibilities:

 Training and Development: The role centres on designing and delivering programs that equip AOD service providers with contemporary, evidencebased approaches to client care. This includes coordinating a range of professional development activities, such as workshops, peer learning forums, and a sector Conference that fosters continuous improvement and collaboration across our sector.

- Strategic Partnerships: The Coordinator works with external organisations and agencies to form partnerships, ensuring AADANT members have access to a broad range of resources and expertise.
- Member Engagement: The Coordinator keeps members engaged by facilitating networking opportunities, providing relevant information, and gathering feedback to continuously improve AADANT's services.

The Capacity Building and Engagement Coordinator role ensures that AADANT members are provided with the knowledge, skills, and tools they need to deliver high-quality services in the AOD sector, ultimately benefiting member organisations and our community.

What We Achieved This Year

As we reflect on the past year, we are proud to share our accomplishments and the progress made in the AOD sector in the NT. Through targeted training, continuous quality improvement, data collection capacity building, and strong advocacy, AADANT has enhanced workforce skills, supported culturally secure practice, and ensured the sector's voice is represented in NT and as part of national reform discussions.

Sector Engagement & Collaboration

AADANT continues to build sector and cross-sector partnerships with key agencies across the NT. Our collaboration with peak bodies such as AMSANT, NTCOSS, NT Mental Health Coalition and the Primary Health Network (PHN) ensured alignment of strategic priorities and coordinated advocacy on harm reduction and culturally secure service delivery.

Key collaborations included:

- AMSANT, NTCOSS & NT Shelter Joint advocacy campaigns on alcohol policy and housing-related harm reduction.
- Aboriginal Community Controlled Health Organisations (e.g. Danila Dilba)
 Support for culturally secure practice and Indigenous-led AOD responses.
- Service providers (FORWAARD, CAAPS, BushMob) – Strengthening workforce capacity and improving frontline delivery.

AADANT's leadership in cross-sector advocacy was demonstrated by co-signing a public open letter with over 200 leaders in September 2024, calling on the NT Government to maintain Minimum Unit Pricing.

AADANT also actively represented the NT AOD sector at national forums, including NCCRED Symposium 2025 and national peak body meetings, amplifying sector voices and influencing policy reform.

Stakeholder Engagement

Territory wide consultations were conducted with member organisations to guide planning priorities and ensure all our sector's voices shaped training and policy development. Regional differences influenced priorities:

- Urban services highlighted workforce retention and emerging substance use patterns.
- Remote communities emphasised culturally secure practice and improved service access.

Feedback was gathered through participant surveys, workshop evaluations and follow-up interviews, ensuring continuous improvement in planning and training delivery.



Workforce Development & Training

Workforce development continues as a core activity, with more than 25 training programs delivered across the NT. Key initiatives included:

- Harm Reduction PD Event October 2024.
- Virtual AOD Conference November 2024.
- Sobering Up Shelter Staff Training March 2025.
- Youth on Ice Training April 2025.
- WOSSCA Multi-Phase Training Series lune-August 2025.
- Dual Diagnosis workshops content is currently being developed. Workshops will be delivered throughout the NT in the 2025 - 2026 financial year.

A Harm Reduction Booklet is also being developed following requests from the sector to strengthen practice guidance and consistency across services. We would like to acknowledge Dr Molly Shorthouse for reviewing the resource, which will be published and made available to member services in the coming months.

The Community of Practice (CoP) met twice, promoting peer-led learning and case-based problem-solving. Members reported improved referral pathways, better cultural safety practices, and stronger collaboration as outcomes.



Governance Support

AADANT continues to uphold strong governance practices to ensure transparency, accountability, and alignment with strategic objectives. The Board of Management provides effective oversight of operations and direction, meeting regularly to review performance, finances and compliance.

This year, the Board undertook a comprehensive review of AADANT's Constitution to ensure alignment with the Model Constitution and contemporary governance standards. A Special AGM will be held to seek member approval of the updated Constitution, reinforcing good governance, clarity of roles and long-term sustainability.

AADANT also supported governance improvements across member organisations by reviewing and updating policies and procedures to reflect legislative changes and introducing peer reviews in rehabilitation services to strengthen case management, data recording and organisational accountability.

Advocacy & Policy Development

AADANT advanced evidence-based and culturally secure policy through submissions and advocacy campaigns, including:

- Inquiry into Youth Justice and Incarceration Opposed punitive approaches in the NT, advocating for harm reduction, youth-focused services, and public health responses.
- Inquiry into Health Impacts of AOD in Australia Called for transformative reform, reframing AOD as a health issue, not a criminal one.
- Ongoing advocacy for Minimum Unit Pricing Supported by joint campaigns with AMSANT and others.

These submissions and campaigns positioned AADANT as a strong voice for human rights, prevention and culturally responsive service models.

Continuous Quality Improvement

AADANT embedded Continuous Quality Improvement (CQI) into its activities through:

- Policy and procedure reviews.
- Service mapping and gap analysis.
- Workforce surveys (profiling, competency gaps, emerging needs).
- Evaluation of all training and workshops, including impact assessments for comorbidity workshops.

This process ensured services were responsive to emerging issues, legislative reform, and AADANT member needs.

Sharing Data & Building Capacity

AADANT strengthened cross-sector reporting and information-sharing through:

- Collating and analysing service-level data, identifying emerging issues, and sharing research summaries in monthly sector updates.
- Providing advice to government on data trends, particularly around comorbidity and remote service access.
- Hosting a webinar on the AODTS-NMDS led by Rebecca Lang (QNADA CEO) covering scope, reporting requirements, ethical data collection and consent processes.

Monthly newsletters featured research summaries such as methamphetamine use trends in rural NT and remote comorbidity needs, building members' capacity for accurate, ethical and timely reporting. A member survey on peer work and lived experience roles further informed workforce planning.



Communications & Engagement

AADANT maintained strong communication across the sector and with our stakeholder networks throughout 2024/25 using bi-monthly e-newsletters, updated website resources and active social media campaigns across LinkedIn, Facebook and Instagram. These platforms were used to share NT-specific harm reduction messages, promote training opportunities, highlight new research and provide updates on the annual conference, including recognition of NT AOD Award recipients. Innovative formats such as infographics, short videos and member case studies ensured information was engaging and accessible to frontline workers.

Regular monthly webinars were also delivered to the sector, with all recordings made available through the newly revamped website. The website underwent a significant upgrade, adding an events calendar, a member portal, webinar archives and a dedicated conference page. A dedicated conference webpage and Facebook page extended engagement beyond attendees, allowing the success of each event to be highlighted and preserved beyond the conference itself.

The bi-monthly newsletters remained a cornerstone of AADANT's communications strategy. Each edition provided timely updates on policy and advocacy, research, training opportunities and funding, alongside member spotlights, cultural events and sector achievements. By combining these communication channels, AADANT ensured members and stakeholders were informed, connected and supported, while also strengthening collaboration, visibility and momentum across the NT AOD sector.



AADANT Conference 2025

The AADANT Conference 2025 – Voices of Change was held at the George Brown Darwin Botanic Gardens on 13–14 May, followed by post-conference workshops on 15 May. More than 120 delegates attended, representing services from across the Northern Territory and interstate, making it one of the largest and most engaging AADANT events to date.

The theme *Voices of Change*- Leading the Way resonated strongly with participants, reflecting a shared commitment to amplifying lived experience, promoting culturally secure practice, and advancing systemic reform. Feedback confirmed the event's value, with participants highlighting the quality of speakers, the diversity of sessions, and the strength of sector networking opportunities.

AADANT would like to sincerely acknowledge the Conference Steering Committee for their guidance and support in planning the event: Genevieve Dally (CEO, Northern Territory AIDS Hepatitis Council), Dr Amanda Davies Senior Consultant. (Secretary and and Dr Cassandra Wright 360Edge), (Senior Research Fellow, Menzies School of Health Research). Their expertise and leadership were instrumental in shaping a program that reflected the needs and priorities of the NT AOD sector.

The program featured 47 presenters across keynote sessions, panels, and workshops. Keynote speakers included Professor James Ward, who spoke powerfully on stigma and racism in healthcare, Rebecca Lang, CEO of QNADA, who outlined national policy perspectives and Dr Christine Watson, who drew on her extensive NT experience in addiction medicine.

Other keynote contributions included Dr Wilson. who Dan emphasised collaborative. community-led health systems; Dr Ingrid Wilson, who addressed the intersection of alcohol and gendered violence and Adrian Farrugia, who explored lived experience in service frameworks and stigma reduction. The program also included Will Tregoning (Unharm), Joe Coyte (The Glen), Ali Lloyd (NT PHN) and Dr Ameina Brunker and Danielle Woods, whose presentations highlighted Indigenous-led models, law reform, commissioning and communitydriven strategies.

The post-conference workshops, delivered by Alex Lee and Joe Coyte from The Glen, provided practical tools on collaboration ("We Can't Work in Isolation") and data use ("How Can Data Help Our Work"), equipping participants with skills to strengthen partnerships and measure outcomes.

The event also hosted the NT AOD Awards 2025, celebrating excellence in harm reduction, Indigenous programs, youth work, and treatment services. With record nominations and broad sector participation, the awards showcased innovation and leadership across the Territory.

Generous support from sponsors and partners was instrumental to the conference's success. AADANT acknowledges the Northern Territory Department of Health as a core funder, whose continued partnership enables our work in strengthening the NT AOD sector.

We also extend our appreciation to the Northern Territory PHN, our Platinum Sponsor, for their ongoing support and commitment to improving health outcomes across the NT.

An independent panel of external reviewers had the difficult task of selecting finalists and winners from a pool of inspiring entries.

The Methamphetamine Outreach Program (MOP) was celebrated for its unique, assertive outreach model, meeting clients where they are and providing timely, targeted support. It is the only program of its kind in Australia, with 100% of participants saying they would recommend the service to others — a testament to its impact and innovation.

Over the past year, AADANT has demonstrated significant impact across the Northern Territory AOD sector. We have:

- Delivered extensive workforce development programs tailored to both urban and remote contexts.
- Strengthened governance and CQI systems across member services.
- Facilitated meaningful partnerships that enabled integrated, culturally secure care models.
- Positioned the NT AOD sector at the forefront of harm reduction and public health advocacy through evidence-based submissions and campaigns.
- Amplified sector achievements through the NT AOD Awards and Conference 2025.

The collective effect of these initiatives has been improved service capacity, stronger cultural security, and a more unified sector voice in both Territory and national conversations. AADANT's commitment to collaboration and evidence-informed practice has ensured tangible outcomes for members, clients and communities, laying the foundation for continued progress in 2025–2026.



Financial Report 2024/25

Throughout the past financial year, the sector has continued to navigate significant challenges, particularly in relation to workforce capacity, funding constraints, and rising service demand. In response, AADANT remained steadfast in its purpose, maintaining a strategic frontline focus and investing in targeted preparation and the development of well-designed, high-impact tenders. This forward-thinking approach has enabled us to maintain a strong and engaged membership base, reinforcing the value of our role as the peak body for the Northern Territory's alcohol and other drugs sector.

AADANT is pleased to report that underspends from the NTG Core Funding and the Commonwealth Department of Health Sector Capacity Building grants have been secured and rolled over, as reflected in our financial statements.

These underspends were primarily the result of savings in salaries and wages. We have strategically allocated these funds to support the redevelopment of the Case Management Toolkit. A resource that has been identified as a high priority across the sector.

This initiative reflects our commitment to reinvesting in tools and resources that directly strengthen service delivery and support for people accessing AOD services in the Northern Territory.

Following a year of dedicated strategic planning, preparation, and successful grant applications, AADANT is poised to deliver two major training initiatives in 2025/2026 that will strengthen sector capacity across the Northern Territory.

These initiatives reflect our commitment to building a more skilled, connected, and responsive sector. We look forward to delivering high-quality, accessible training that empowers frontline workers and strengthens community outcomes across the Territory.

Looking ahead, AADANT remains committed to financial sustainability and further strengthening our membership and sector-wide impact. The financial statements for the 2024/2025 year have been prepared in line with all applicable accounting standards.

We now present the audited financial report, offering a transparent and accurate reflection of AADANT's financial position for 2024/2025.
