#### The Atkinson Lecture: The Shifting Regulatory Landscape: Navigating Uncertainty and Opportunity



**Evan C. Zoldan**University of Toledo College of Law

Evan Zoldan researches legislation, including legislative power, the legislative process, and statutory interpretation. His work on legislative power questions whether Congress and state legislatures may target named individuals for special treatment.
