Jarkesy* and *Corner Post, Inc. v. Board of Governors of the Federal Reserve System*. Participants will gain insight into the evolving role of administrative agencies, the shifting balance of judicial review, and how state-level responses are shaping the future of regulation.

The session will also review pending cases with potential regulatory impact, including challenges related to bans on conversion therapy, veterinary-client-patient relationship requirements, and the use of drones in land surveying.

Maintaining Relevancy During an AI and Digital Evolution

As artificial intelligence and digital technologies reshape professional practice, regulatory boards must evolve to uphold their public protection mission. This closing session will examine the changing role of licensing boards in responding to emerging technologies and maintaining regulatory relevance.

Meyers will address the legal and regulatory challenges posed by AI, including its impact on scopes of practice, the introduction of new risk areas, and the need for updated oversight strategies. Drawing on the work of the Federation of State Medical Boards, he will offer practical guidance for responsible regulatory action. Nelson will present recent national research from the Alliance for Responsible Professional Licensing, highlighting strong public concern about AI use in high-impact professions and broad support for licensing boards to lead in its governance.

Participants will gain insights into the regulatory, ethical, and public trust implications of AI—and how boards can lead in shaping responsible, forward-looking policies.
