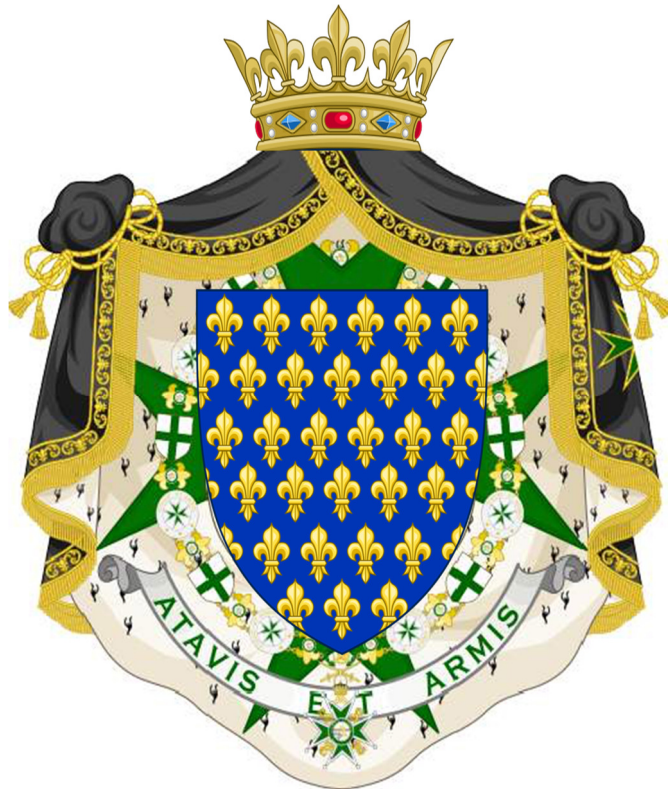


NOTICE FOR THE SUBMISSION OF CANDIDATES FOR THE ELECTIONS OF SENATORS OF THE LAZZARITA ACADEMY OF KING SAINT LOUIS IX OF FRANCE



The Lazzarita Academy of King Saint Louis IX of France, in accordance with its Statute and in execution of the Rectoral Decree n. 07/ret/2025 dated 25 August 2025, announces elections for the renewal of the office of Academic Senator for a four-year term.

The Senators represent a fundamental component in the management and development of the Academy's activities, actively contributing to the promotion of its cultural, scientific, and moral goals.

The Rector, in compliance with the statutory provisions (Article 4, letter a), point 5), has decreed the following appointments:

- with Decree No. 2 of July 13, 2025, the appointment of the Chancellor of the Academy, in the person of Eng. Gervasio Venuti, Lazzarita Academician enrolled in the academic category "Medical, Mathematical, Physical, and Engineering Sciences," Officer of the Military and Hospitaller Order of Saint Lazarus of Jerusalem;
- with Decree No. 3 of July 14, 2025, the appointment of the Scientific Director of the Academy, Professor Count Giovanni Maria Fortebraccio Morsiani, Full Academician enrolled in the academic category "Moral, Historical, and Philological Sciences," art historian, cynologist, and writer;
- with Decree No. 4 of July 25, 2025, the appointment of the Senator (appointed by the Rector) His Excellency Dom Vittorio Giovanni Rizzone, Mitred Abbot of San Martino delle Scale, Ecclesiastical Commander of the Military and Hospitaller Order of Saint Lazarus of Jerusalem;
- with Decree No. 5 of July 25, 2025, the appointment of the Senator (appointed by the Rector) Most Reverend David Hamid, Bishop Emeritus of the Diocese of Europe of the Church of England, Ecclesiastical Commander of the Military and Hospitaller Order of Saint Lazarus of Jerusalem.

To complete the constitution of the Academic Senate, it is necessary to proceed with the election of six Senators, pursuant to the aforementioned Article 4, letter a), point 5, of the Statute.

All **Ordinary** Academicians and **Lazzarites** may submit their candidacy, as prescribed by the same Article 6 of the Statute.

Application Submission Procedure

Applications must be submitted no later than midnight on September 15, 2025. Applications must be drafted in accordance with the following text:

I, the undersigned, (Name and Surname), Ordinary Academician/Lazzarita of the Accademia Lazzarita Re San Luigi IX di Francia, PRESENT my candidacy for the election of Academic Senators, for a term of four years.

I DECLARE that I am familiar with the Academy's statutory regulations and the duties and obligations associated with the office of Senator.

Electoral Process

The elections will be held **by open vote**, in accordance with the procedures established by the Statute. The voting procedures will be communicated to all Academic Senators entitled to vote by September 30, 2025.

Announcement of the Elected

The announcement of the elected Senators will take place by November 30, 2025, and will be duly published on the Academy's website and communicated personally to those interested. The elected Senators will take office upon the first convocation of the Senate.
