As a non-profit, full service youth soccer club, Sporting Nebraska FC strives to provide an affordable and competitive experience for all Sporting Nebraska FC members. Financial Assistance is provided on a first come, first serve basis, and is based upon the allocated funds set forth by the Finance Committee, along with financial needs of the family.

Financial Assistance is awarded on an annual basis and is reviewed in conjunction with the Team Formation time frames set by the Nebraska State Soccer Association and can only be submitted and reviewed upon the player receiving an Invitation to join a team. The amount of financial assistance funds available is finite and based upon the budget of Sporting Nebraska FC.

Financial Assistance applications are reviewed by the Finance Committee, which consists of Sporting Nebraska FC board members. Information submitted is confidential and is used for the sole purpose of determining eligibility for financial assistance.

Financial Assistance awarded is only for Registration with Sporting Nebraska FC per NSSA policies. ***All Team Fees, Personal Travel Fees, Training Kits, Uniforms, Camps, etc... are the sole responsibility of the family, so be sure you are able to budget for those additional costs before applying.*** Additionally, Sporting Nebraska FC provides an Installment Payment Plan for all families within our programs and that information is available upon registration of your child.

The Deadline to submit a Financial Assistance Application is listed below and Sporting Nebraska FC will not accept any applications after the listed deadline dates and no further applications will be accepted after July 15th or once all of the allocated funds have been exhausted. No applications will be accepted after November 1st, 2025.

- U11-U19 Age Groups
 - Submission Deadline is June 22nd.
- Competitive Program Players - Submission Deadline is June 22nd
- Omaha Academy Players - Submission Deadline is June 15th
- Lincoln Academy Players - Submission Deadline is June 22nd

Sporting Nebraska FC Financial Assistance Program

The Sporting Nebraska FC Financial Assistance Program provides families in need with financial support to participate in program activities. All information is kept confidential and will only be shared with the financial committee.

How do I apply?

(1) Complete the confidential application on the next page and submit as follows:

a. Email: Renew@SportingNebraskaFC.com

b. Mail or drop off to Sporting Nebraska FC Attn: Scholarship Program, 14706 Giles Rd, Omaha, NE 68138

(2) Submit copies of the following **REQUIRED** documents:

1. Most recent year's Federal Income Tax Form (1040 Form).
2. For a non-filer of Federal Income Tax, contact the Internal Revenue Service at 1-800-829-8374 to request a letter of verification of non-filing and submit it with your financial assistance application.

(3) Families receiving Financial Assistance from the club will be **REQUIRED** to Volunteer at least **4 hours** of service time during Club Events throughout the year. You will be notified of those opportunities via email if you qualify to receive assistance. Failure to complete the required hours will result in the loss of the applied scholarship for the current year and ineligibility for further scholarships. In addition, the balance of the scholarship dollars applied will be your responsibility for payment.

(4) Any families that have received Financial Assistance from Sporting Nebraska in a previous season, should expect to receive a lesser amount each following year that they apply and qualify for financial assistance.

(5) Any family receiving financial assistance can **ONLY** be registered with SNFC for the seasonal year, and will not be allowed to register with any other Club during that time. Failure to comply with this will result in the loss of the applied scholarship.
