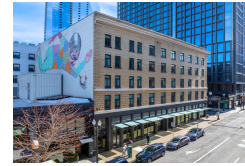

Required Pre-Lease

- Application Fee (Non-Refundable).....\$55.00 **Per applicant/Once**
- Security Deposit.....N/A **N/A**



Required Essentials

Electric Service and Renter's Insurance are set up directly with the provider.

- Utility-Gas, Water/Sewer, Trash.....**Varies (Based on usage)** **Monthly**
- Utility-Electric (Pacific Power).....**Varies (Based on usage)** **Monthly**
- Renter's Insurance.....**Varies** **Per policy**

Gas, water/sewer, and trash are billed separately by the property monthly using a standard allocation formula.

Electric service must be set up by the resident before move-in; billing and payment are the resident's responsibility.

Renter's Insurance is typically required; please confirm your specific requirement in your lease. Residents may use any provider, or purchase coverage through FolioGuard (AIS) in the Online Portal..
