### 1100-1200 Training on Life Flow and Qin Flow equipment (all members)

- Representatives from Life Flow and Qin Flow gave hands on training to all members of the RAC regarding the use of the two devices.
- Contact information was given so that hospitals and agencies can have training sessions if needed for their facilities.

# 1200-1230 Lunch (provided) and speaker- Larry Mosvik: Telehealth

- Right Site Health came in to discuss a project in conjunction with Beaumont Fire and other agencies across the nation.
- Identified that a significant volume is low acuity and non-emergent patients which drives down efficiency to deal with high acuity patients.
- Instead of transporting low acuity patients offer to have an ED physician speak with them right there at that moment through a tablet. Activated by the dispatch center or by the crew on scene.
- Physician de-escalates and triages. They can treat minor emergencies over telehealth and help identify barriers to care and remove those barriers (health literacy, transportation, financial barriers, etc.).
- Gave statistics regarding how they are doing with Beaumont Fire.

- FY2026 grant fund \$162,800, El is \$150,000, RAC/EMS is \$97,024, and system development is \$84,476 (147.00 decrease from FY25).

## 1245-1255 Executive Report- Alyson Nickum-Smith

- Rac dues need to be at the RAC office by Nov 14<sup>th</sup>.
- Texas Wristbands Sept. 1, 2025, should be applying arm bands to patients coming in by EMS.
  - Hospitals should be banding patients transferred out with no EMS wristband applied before arrival to the hospital.
  - Will send a survey out to the hospitals regarding transfers out to look at buying some wristbands for hospitals.
  - Arm bands are not in yet, they are ordered.
- Texas Pre-hospital Whole Blood There is 10 million in funding and 14 million was asked for.
  - RAC will be reaching out to confirm numbers
  - Contracts must be signed before reimbursement happens.
- RAC Website Changes were discussed
  - Committees under trauma there are resources, tool kits, follow-up letter templates. The RAC office will help any other committees link resources so please reach out to the office.
  - SOPs: it will show your attendance and whether you were virtual or in person.
- RAC self-assessment OFIs were presented to the GA.
  - RAC PI Plan and PI committee
  - Outcome data in the region EMS/Trauma is data driven.
  - ESO repository for hospital and EMS
    - Expense for the RAC but we can have the data and look at it for Trauma and EMS to start. Moving forward they will be looking at stroke and cardiac first and followed by maternal.
    - No cost to EMS or hospitals- deidentified data
  - STB statistics were given
    - New QR code will be sent out
    - Ask for the exact number of students
    - New data elements are being requested per the RAC.
  - GETAC updates
    - All about whole blood, survey guidelines and implementation of the new rules and ED LOS for transferred patients.
