**For multi-unit developments, where one builder is constructing adjacent units or houses, there is a discretionary scale of discounts, depending on the financial assessment of the builder, experience and quality of previous work and the number of contiguous units, commenced together, according to the following scale.**

<b>Number of Units</b>	<b>Maximum discount</b>
<b>2 to 5</b>	<b>up to 5%</b>
<b>6 to 10</b>	<b>up to 10%</b>
<b>11 to 20</b>	<b>up to 15%</b>
<b>21 to 50</b>	<b>up to 20%</b>
