- Park Board Seat Opening Patrick Berg formally applied for the open Parkboard seat;
 Berg accepted our invitation to visit our meeting; Hoffarth makes a motion to approve
 Patrick Berg for the open seat; Gibbon seconds
- Newport Park With the rain, we saw how the water will fill the retention pond and will adjust vegetation plans; Sheena Batson has a \$750 grant and will plant flowers and other vegetation this summer
 - i. She will need landscaping fabric \$150 & possible fencing to keep pests out from the parkboard
 - ii. Hoffarth requests \$1000 set-aside to work on the first phase of the project; the next phase next year we will put in trees and gravel trails next summer
 - iii. Sarh makes a motion to approve set-aside money; Gibbon seconds
