## **Ask a CASA**

The CASA team asked advocates:

What would you say are the benefits of a child being assigned a CASA by the courts?

#### -Tina Webber

I believe one of the greatest benefits of a child being assigned a CASA is that they gain an advocate who is solely focused on their best interests—someone who isn't part of a larger system or caseload, and who is there with the sole purpose of investing time, energy, and consistency into THEIR life. A child's CASA can help bridge communication between parties involved in different aspects of their lives. Through it all we help to ensure the child's voice doesn't get lost and to offer a more holistic view to the courtroom—one that centers on the children, not just the case.

It's important to remember that CASAs often become the one person who stays the same for children across multiple placements, hearings, and/or staff changes. This consistency allows us to better build trust with the children we serve, and to try to truly understand their needs and wishes. We are then equipped to provide the court with detailed, firsthand insight. Our input then can, and often does, influence a family court judge's decisions around services, visitation, and permanency.

CASA ensures the child's BEST INTEREST is the focus to ensuring the child's likes, dislikes, needs and wants are addressed in his/her educational setting and home placements while ensuring medical oversight based upon his/her age and medical diagnoses. Being assigned a CASA ensures one consistent person is aware of the child's educational and home placements and medical concerns throughout the duration of his/her foster care experience.


