JU Form 9	Filing Fee Payment Plan	Give this form to the Clerk if you have filed a Civil Fee Waiver Affidavit and Order
JU Form 11-B	Agreed Judgment Entry to Modify Custody	If you have completed JU Form 5, submit this form if this is a change of custody case.
JU Form 10-B (Motion to modify custody)	Entry granting Temporary Emergency Order of Custody	Submit this form if you have requested a temporary emergency custody order. Leave the hearing date/time blank. The court will fill out if granted.

STATEMENT OF UNDERSTANDING FOR LEGAL CUSTODY

Pursuant to R.C. 2151.353(A)(3), a person who is proposed as or intends to obtain legal custody of a child may only be awarded custody if he/she has signed a statement of understanding containing the following provisions:

1. It is my intent to become the legal custodian of _____.
2. I am able to assume legal responsibility for his/her care and supervision.
3. I understand that legal custody is intended to be permanent in nature.
4. I understand that I will be responsible as the custodian for the child until the child reaches the age of majority.
5. I understand that my responsibility will continue beyond the age of majority as long as the child is still in school.
6. I understand that the parents of the child have residual parental rights, privileges, and responsibilities, including, but not limited to, the privilege of reasonable visitation, consent to adoption, the privilege to determine the child's religious affiliation, and the responsibility for support.
7. I understand that I must be present in Court for the dispositional hearing in order to affirm my intention to become legal custodian, to affirm that I understand the effect of custodianship before the Court, and to answer any questions that the Court or any parties to the case may have.
