TRANSIENT GUIDELINES

1. Check-out time is 11:00 a.m.
2. Courteous and considerate conduct is required on marina premises at all times.
3. All vessel owners will observe rules of safe boating at all times.
4. Children must be supervised by an adult when off the boat.
5. All pets must be kept on a leash. Please do not walk your pets in the recreation areas or around the pools.
6. Please do not place chairs and hoses on the pier.
7. All parties and large congregations must be moved inside and quiet by 11:00 p.m.
8. No open flames or barbecue cooking is permitted on the dock or on any vessels moored in a slip.
9. All trash and recyclable items are to be placed in the corresponding receptacles provided for that purpose.

Slip renter shall be responsible for all costs and liabilities of and relating to slip renter's use and occupancy of Haven Harbour Marina's and Haven Harbour South's slips, piers, and other facilities, including but not limited to, the swimming pools, grills and bicycles (collectively the "Marina Facilities"). In addition, by the execution hereof, slip renter agrees to indemnify and hold the marina harmless from any and all costs, liabilities and damages (including attorney's fees, court costs, and insurance costs and deductibles) caused by (directly or indirectly) or relating to slip renter's use and occupancy of the Marina Facilities. This allocation of responsibility and indemnification by slip renter shall also be for and include these acts, omissions, and/or negligence of slip renter, his or her family, guests, invitees, employees, agents and all other persons who make use of the Marina Facilities as a result of slip renter's use and occupancy of the marina pursuant hereto. The slip renter understands and agrees that the marina shall not be liable or responsible for any personal injury, loss or death, property loss or damage due to the acts, omissions or negligence of slip renter and/or as a result of fire, theft, vandalism, rain, hurricane or other casualty loss.

¹ Transient dockage includes use of all marina amenities, including heads, showers, swimming pools, waste disposal services and more.
