Chairman's Report to the Committee - 20th January, 1977

DISCO I would like to express my thanks and appreciation to all those Committee Members and their helpers who worked so hard to make this first social event a great success. A letter of thanks has been received from Chris Lurcock.

SITES - Monkton Chalk Pit - Application again rejected but applying for a third time hopefully with support of the local Police.

- Peters Pit, Wouldham - Graham Mitchell has confirmed in writing the agreement of Gravesend Eagles for us to approach APCM with a view to KYTC using this site for the National on 4/9/77. I have written thanking Graham and the Eagles Committee and I have also applied to APCM.

Tibbs Court - Thanks to Trevor Dobbs and his boss for the use of Tibbs Court on 16.1.77 and for permission to use it again for Practices on 5/6th February and also for the Trial on 24th July, 1977. Should we send letter of thanks to 'boss' ?.

Dane Valley - Although the TDC Development Committee agreed in October we have still not received a Licence - I have taken up the matter with Cllr Hudson.

Other Sites - We must have more sites - ideally a site should not be used more than twice a year for a Trial and should have adequate 'off-road' parking facilities.


NOISE A negative point at our Trials is that we have allowed riders to run their engines at the Start Assembly. It was largely as a result of this noise that the problems at Lodge Lees came to a head and it puts the use of any site at risk. It should become a Club Rule that Bikes are silent while awaiting Scrutiny and the Bike is only started when the Rider is so instructed by the Scrutineer.

MEMBERSHIP There are 54 family memberships comprising a total of 73 Riders

## Numbering System


After much discussion a proposal was put forward to reverse the present number system and adopt the issuing of numbered bibs to riders, that would indicate the position they would be leaving the start.





## RIDING RULES

1. General The A.C.U. General Competition Rules, the A.C.U. Standing Regulations for trials (except where varied by the Youth Division Regulations) and the A.C.U. Youth Division Regulations will apply to all events organised by the Kent Youth Trials Club.
2. Responsibility for Youth Riders A parent, guardian or responsible adult must accompany a youth rider to a meeting, will make known his/her presence by signing-in on arrival and stay for the duration of the time that the youth is present.
3. Applications to ride Applications to ride, accompanied by the appropriate entry fee and a large (9"x4" minimum) stamped, self-addressed envelope, must be received by the Competitions Secretary not later than one week before the date of the event. A rider whose application is not accepted will be notified as soon as possible and the entry fee will be refunded.
4. Safety precautions A chain guard or guards must be fitted on all machines to cover the entry of the chain to the gear box and rear sprocket. Only ordinary pump petrol will be used and machines will be adequately silenced and have self-closing throttles and effective brakes. No sharp edges which could cause injury will be allowed. A rider must be able to touch the ground with the balls of both feet when sitting astride the machine in a normal riding position. The Committee or appointed club official will withdraw any rider at any time if that rider, in their opinion, constitutes a potential danger to him/herself or others by riding or because of the condition of the machine.

5. Protective clothing and helmets Helmets bearing the ACU approved stamp or helmets of a BSI approved type for road use in sound condition and properly fitted must be worn by all riders while practising and competing. Chin cups must not be used. Strong protective clothing covering the body, including the arms, must be worn and shall include gloves and stout footwear. Nothing hard such as coins or tools will be carried in pockets while riding.
6. Scrutineering Riders and machines will be inspected before the start of any competition or practice to ensure compliance with rules 4 and 5. The scrutineers are empowered to exclude any rider or machine which does not, in their opinion, meet the requirements of the club or constitutes a possible danger to the rider or others.
7. Riding numbers Riding number will be displayed clearly at the front and rear.
8. Marking of observed sections Each observed section will be numbered consecutively and the start and end of each section will be indicated. The route to the start and between sections will be indicated by arrows or markers ( S.O. = straight on, R = turn right, L = turn left ).
9. Points system In competitions the marking of points will be 0 - 1 - 2 - 3 - 5. ties will be resolved by the greatest number of cleans, followed by the least number of marks lost progressively round the course. Observed sections will be ridden once only per lap. Having completed an observed section a rider may ask the observer and the observer may tell a rider his/her score. However, in the event of a disagreement a rider is not allowed to dispute a score with an observer, but may lodge a written protest with the Clerk of the Course during the meeting or the Competition Secretary after the event in accordance with Standing Regulation for trials No 26.
10. Awards In competitions awards will be made in each class as follows:-  
2 - 5 riders - one award; 6-10 riders - two awards; 11-15 riders - three awards, etc.
11. Duties of adults It is a condition of entry in a competition or practice that the adult accompanying the rider may be required to fulfill certain duties such as observing. Observers and other officials are required to sign on before the start of an event, wear armbands issued at the control and sign off at the end of the event.
12. Signing on and off A rider must sign on before the start, and sign off at the end, of a competition or practice. A rider who fails to sign off will be deemed a non-finisher and will not qualify for an award.
