Dear

On Sunday night I received a 'phone call from Brian instructing me, in a polite manner, to enrol Brett Syndercombe as a member of K.Y.T.C. My immediate response was one of dismay and annoyance because this is the second time this has happened since being asked by Brian, prior to the A.G.M., to accept the responsibility of Membership Secretary (if elected).

I told Brian that I felt his action was unconstitutional. He said the lad had turned up at the practice on 11/9/77 after making an application to join the club dated 8/9/77, which I received on 10/9/77. Brian called a special committee meeting and the lad was elected to membership. I contend this special meeting was also unconstitutional in view of the fact that all committee members were not informed of it. Brian is quite unrepentant and says he can see the same thing happening again in the future.

I maintain that the lad's parents should have been informed politely, but firmly, that they could not partake in club events until elected as per the club rules. (Please refer to our Constitution and also Committee Manual, Membership Secretary, duties).

I consider I have fulfilled my position as diligently and competently as I am able since accepting the job of Membership Secretary and I do not deserve this "high-handed" treatment. It is the chairman's duty "to ensure that the committee acts within the framework of the Club's rules and constitution". This surely must apply to the Chairman himself.

You are all well aware that I am deeply concerned about the number of members we should accept in conjunction with the amount of land available to us, and the consequent dissatisfaction to existing members. At the committee meeting on 22/4/77 a resolution was passed and minuted that membership would be reviewed when it reached 100. To date this review has not taken place although after the election of all applicants at the August meeting Brian did inform those present that membership then exceeded 100.

I might point out that at the time of my receipt of Brett Syndercombe's application I was already holding two other applications to present to the committee at the next meeting.

Let me state quite clearly that I have the greatest admiration for Brian's drive and enthusiasm in setting up the K.Y.T.C. Without a doubt we are all in his debt in that respect. In the early days he no doubt became accustomed to making decisions on his own to ensure the growth and progress of the club. His leadership has been an inspiration to us all.





CHAIRMAN'S REPORT TO COMMITTEE  
MEETING ON 21ST OCTOBER, 1977

The Past

Three major events took place during the last few weeks - our first National Trial on 4th September - the Kent Youth Spectacular Display on 10th September and, more recently, the Royal British Legion Youth Trophy Trial on 16th October. All three events were very successful both in terms of organisation and enjoyment and I place on record my appreciation and thanks to all who devoted their time to the work and preparation required for these events.

Experience has taught us the importance of having a regular and reliable vehicle for communicating with the membership and I welcome the decision taken at the last meeting which will ensure that each family membership will receive a copy of each newsletter.

The Present

There are areas which must engage the attention of this meeting and the two other regular committee meetings scheduled for November and December.

Regulations, Entry Forms and maps have been produced for the Trial of 4th December, 1977 and I attach a copy of the maps which have been made available to the Essex Schoolboy Trials Club. Jan Towns has told me that ESTC has 11 juniors and 2 cadets - I would like to be able to tell her that our Trial on 4.12.77 will cater for these younger riders while also providing challenging sections for the more expert riders.

In the time available can we plan to have a few sections only for juniors and cadets?

We must also be thinking about the Riding Rules for 1978. The enigmatic "Bike Major" in this month's Newsletter has spoken of awarding 7 for misses. Perhaps the simplest way of solving the problem of "missed" sections would be to leave the present points systems as it stands while making it known that a rider who misses a section will be considered as a non-finisher, whose results will not be calculated and will not qualify for an award. In this context it may be wise to consider relating the number of awards to the number of finishers instead of, as at present, starters.

While thinking about the Riding Rules the Committee must consider the amendment which the A.C.U. Youth Division Committee is making to the Youth Division Regulations effective 1.1.78 from which date the "Chain Guard" Rule will apply only to speed events. We must decide whether or not to retain compulsory chain guards as a club rule. I am very much in favour of compulsory chain guards.

"Hints for Observers" was printed in time for distribution at the last Trial and a copy is attached for your information. Don produced this document. As a follow-up, I have written a "Check List for Machine Examiners" and attach a copy for your perusal and the Committee's discussion and decision.

The "present" is very much concerned with planning for the future and the continuing success of the club.

The Future

It is my hope that the K.Y.T.C. will continue to grow steadily and mature wisely. Now that the ACU Youth Division dates are known I have re-written the calendar for next year as I believe many of our riders will wish to ride in National Trials without missing the club's monthly Trials. A few of the known schoolboy events to be organised by Adults Clubs are also mentioned. Thanks to Doreen and Roy, who have obtained the use of a new site (Mays Farm, Barming) for the K.Y.T.C. the calendar can now be written for the whole year mentioning sites and times.

However, I am not suggesting that the sites should be made known publicly more than two or three months in advance. To publicise far in advance could lead to members losing interest in trying to obtain new sites.

As the club grows so does the work load imposed on individual club officials while the proportion of members with no specific tasks or responsibilities also increases. This cannot be good for the health of a club whose policy is to involve each adult member in club affairs. As we look forward to 1978 I believe we must consider reducing the work load of individuals. For example, it may be necessary to separate the Shop from the Treasurer, the Newsletter from the Membership Secretary, Practices from the Clerk of the Course, to set up arrangements for display and so on.

The committee may wish to consider appointing different members as Clerk of the Course for each Trial, while keeping the responsibility for organisation in the hands of one Committee Member as now. A suggested list of K.Y.T.C. organised Trials for 1978 with possible names of Clerk of the Course is attached.

Arrangements set in motion at the Practices in September and October at Little Ruckinge Farm, where the riders marked out sections and new parents were shown the arts of observing, might become an accepted format for 1978 (this view is also expressed by "Bike Major").

An "Under 80's" Trial is suggested so that the younger riders can have their day - this Trial might be laid out and observed by the older riders

I offer these suggestions for discussion in the hope and belief that 1978 is going to be an even greater year than 1977!



## HINTS FOR OBSERVERS

0 Will be recorded when:-

The Rider rides through the section without stopping or putting his feet down and at the same time keeping within the marked boundary

1 Will be recorded when:-

The Rider performs as above but puts his foot down once

2 Will be recorded when:-

The Rider performs as above but puts his foot down twice

3 Will be recorded when:-

The Rider puts his feet down more than twice but keeps moving in a forward direction in relation to the course, keeps astride the bike and keeps within the marked boundary

5 Will be recorded when:-

The machine ceases to move in a forward direction relative to the course. The Rider dismounts. Any wheel of the machine crosses an artificial boundary. The machine travels outside any boundary marker or if the rider is held responsible for breaking and/or removing a tape, marker card and/or support. The Machine or Rider receives outside assistance.

The front wheel spindle is the part of the machine that determines whether or not the rider is in or out of the section. It also determines if the rider has stopped.

M Will be recorded when:-

The Rider fails to attempt the section

If you have any doubts in your mind about the Riders marks please give the Rider the benefit of any doubt.

Be consistent with your marking. Be strict if you wish but be strict with all the Riders.

Thank you for observing. The sport could not continue without you.


