Committee Meeting 18/2/77

On this Friday night, despite torrential rain and gusting winds on the motorway, Alan and I attended our first committee meeting. There was almost a full turnout and it was pretty obvious that it was to be an industrious gathering competently chaired by Brian, with all parties making valuable contributions to the effective running of the club.

Forthcoming events like the National Trial - Christmas Disco - A.G.M. were discussed. As were Club Finance and the future of Lodge Lees.

There was a lengthy review of the February Boxley Trial, and I was asked to bring the following points to the notice of members.

RIDERS:

1. When you arrive at the venue for a Trial please seek out the Control Point and will one parent and rider sign on at once. After that, then you can unload your bike and get ready for the Trial.

2. In future, the actual starting times will be displayed somewhere at the Control Point. This will save riders having to wait a half-an-hour or so at the starting area, and will enable time for competitors and parents alike to have a bite to eat and organize themselves. However, you should report to the start area ten minutes before you are due off to enable scrutineering to take place.

3. Remember, a trial consists of a required number of laps of the course, not riding each section consecutively a required number of times.

4. Make sure your wheels are clean before you enter a section. (Something all those who competed at Boxley will have thoroughly learnt I'm sure).

5. Please make sure you sign off when you've finished. Do not ride around areas where later starters are still competing.

OBSERVERS:

1. As well as signing your rider in, you must also sign as an observer. This is for insurance purposes, and obviously must be done before you go out to your section.

2. Parents prepared to act as observers please report to Bob Simcock at the start, in future.

3. If a rider retires please leave cards blank. Do not insert 'fives'.

It was generally felt that the format of the trial was right. Three laps straight off allows everyone to eat and load up, etc., whilst the results are formulated. It was unfortunate that the route to the early sections was practically impassable for the younger riders but in future the first five sections will be situated for easier access if at all possible.

The older boys will please be tolerant of this arrangement, remembering that the younger boys are probably raw beginners, and not as physically strong, and we need to encourage them to continue. After all the long term future of the club is in their hands. Or even their feet, at this stage !.

The meeting closed about 10.45 and we trundled back up the motorway and just got in bed by midnight.

Don Smith Trials School

The first course for schoolboys took place between 21st and 24th February. There were five riders from KYTC: Alan Chilvers, Antony Dobbs, Robert Prior, Ivor Simmonds and Andrew Soameson. Elsewhere in this issue is a report on the course from Ivor.

Club Trial at Boxley 13/2/77

Although we were once again blessed with fine weather, overnight rain not only caused Bob and Don a lot of extra work on the Sunday morning easing sections but also made the approach to the area practically impossible. Most Dads had their work cut out getting into a parking space and a number of 'fives' were recorded!.

As well as Bob and Don were able to ease sections there was little they could do about the 'clinging' mud between sections at the gully and many front wheels stopped turning until they were either cleaned out or the front mudguard removed. However most lads stuck at it, although in many cases a high number of marks were lost, and those that did eventually enjoyed themselves. This was as much a test of character, as it was riding ability. The first lap took about an hour or so, the second and third about fifteen minutes each !!!.

To those who received awards - congratulations. You certainly earned them. Shane Edwards took the Class B Experts for the second month in succession, whilst his pal Steve Higgins took the Class A Experts, beating January winner James Smith by just one mark. Don's boy Sean won the Class C event and is riding with great confidence now. Nice to see long-standing members Ivor Simmonds, Peter (Honda rules OK) Cressey, Paul Cuckow and Steve Simcock amongst the awards. And congratulations to new members Dave Sparrow and Antony Errey on showing well.

Riding trials though isn't necessarily about winning, it's about keeping going and trying your hardest all the time, even when things seem hopeless. That's what makes the great riders - GREAT. Ability and expertise comes with practise and experience. The amount of effort put in to gain that experience is really the only limiting factor. That and the fact that Dad won't fork out for the latest Suzuki, Rathmell Montessa or Bultaco Sherpa !!!.

Safety Precautions

Whilst I was assisting Don at the start of the February trial at Boxley one or two lads were warned that their chain guards to the lower run of the chain were not sufficient to comply with club rules. A note of the lads' names was taken so if you were an offender please make sure Dad helps you put the matter right before you ride in our trials again. If not you will be excluded from riding.

Due to the undesirability of using Boxley for a third consecutive month it has been decided to hold the 17th April Trial at Lodge Lees. However, car-parking there is very limited so the Trial will be for Class B, C, and D riders only. Start will be at 11.00am, but please try not to arrive earlier than 10.15 as there will be little opportunity for riding before the Trial starts.

Class A Riders are invited to ride on 3rd April, 1977 at Nickle Farm, near Chartham Hatch, where the Invicta Club are holding an Adult Novice and Class A Schoolboy Trial comprising two laps over twenty sections starting at 10.30am. The results of this Trial will count for the KYTC Annual Awards Scheme and the best KYTC riders at this event will get KYTC Awards as well as any trophies awarded by the Invicta Club.

Joining an Adult Club

For Class A boys, in particular, there is considerable advantage in joining an adult motor-cycle club, as well as being a member of K.Y.T.C. You can't obtain a licence for trials from the A.C.U. until you are sixteen. This allows you to ride in "open-to-centre" events held on private ground, but you can take part in a club's "closed-to-club" events, and some Novice trials. The competition is tougher and can only benefit you in the long run. Also, of course, it helps to "spread the gospel", as it were, in regard to youth trials. Although, of course, there are many adults who don't like to be beaten by "kids"! So it is therefore essential that your conduct is a credit to yourself, your family, this club and the world at large. Nobody likes a cocky "know-all". So be polite, obey the rules and instructions of officials, listen to advice (remember you don't have to take it - but surprisingly enough some adults do know what they are talking about), go out and do your best, and most of all enjoy yourselves.

My own club has just produced it's list of "closed to club" events for the year and it provides a variety of venues from March to December. I'm sure there are many clubs that produce a similar programme. If anyone is interested and would like to know how to go about joining such a club; or if anyone knows of an active adult trials club that has such a list of events please contact me.

Another point is, that membership of an adult club entitles you to receive a copy of the South East Centre Gazette. You have to pay extra for it, but it keeps you in touch with all events in Kent, Surrey and Sussex, and also provides entry forms to the various trials you are eligible to enter.

Finally, such a membership brings you into contact with many fine riders, who's style you can study. Men like Richard Whitbread, Gordon Fennings, Gerald Budgen, Mick Sturdey, Gordon Farley, Alan Ketley, Charlie Harris, Tim Bateup, Les Watts,etc. The world doesn't begin and end with Malcom Rathmel you know lads!.

Don Smith's Trials School

I left Headcorn at 6.30pm and at 8.00pm arrived at the Post House Hotel, Brentwood; after parking the car we went into the Hotel foyer where we met Don Smith, who went on to explain details of the course, what time we had breakfast, lunch and evening meal, what time we had to be ready with our bikes in the morning, where to park the bikes, etc. After this we were directed to reception who supplied us with our room numbers and the people we would be sharing with. After depositing my suitcase in my room and meeting my room-mates Antony Dobbs KYTC and Barry Windybags Southampton I returned to the car park to unload my bike. All of the bikes were parked at the rear of the Hotel where you also had to leave your can of spare petrol. The bikes were checked hourly by hotel security and I must admit nobody lost anything from this compound. I returned to my room and settled down to watch TV, we then decided to go to bed, but as raiding parties were sent out from other rooms to topple people out of bed, we had to participate in the fun.

Next morning we had arranged for reception to give us a early morning call this allowed plenty of time to get ready for breakfast, breakfast consisted of bacon and eggs. Don Smith instructed us to be at the front of the hotel after breakfast. Myself and Paul Geeves were instructed to load the bikes into the Transit Pick-up. We travelled with the driver. Afternoon - Don Smith explained techniques of riding down banks, then proceeded to demonstrate with his Ulf Karlson Replica Montessa 250.

Day Two Morning/Afternoon - more demonstrations and advice from Don how to improve our riding ie logs, turns, water, etc.

Day Three Mini Trial consisting of 25 sections.

Evening - results of Trial - lecture by Don Smith of the Course also his opinion of our riding ability and what he considers we would obtain if we kept practicing.

Footnote I consider we had very good tuition also we had lots of laughs and I would thoroughly recommend this course to any rider considering it.
