FINAL INSTRUCTIONS

1. Final Instructions of sections and laps will be displayed on the day.
2. Section markings - Blue Left, Red Right, Deviation of Yellows for B's where applicable.
3. Time limit is 5 hours 30 minutes, riders must sign off at the end of the trial.
4. Please present machines, helmets, gloves and boots for scrutineering, which starts at 9am, before signing on.
5. The car parking and start areas are silent zones, no starting of machines will be permitted until called to do so.
6. When a 5 penalty has occurred, the rider should quickly, where possible, move his machine from the section, to help avoid delays to other riders waiting; this will often mean pushing the machine out of the section, so that the next rider can attempt it without waiting longer than necessary.
7. No riding or practising before the event, no dangerous riding between sections.
8. On grounds of safety riders must not leave the marked course at any time, no riding in the opposite direction between sections; access to the car park is permitted when necessary. Please continue in the correct direction around the course.
9. All riders to change punch cards at Secretary's tent at the end of each lap.
10. Observers and stewards meeting at 09:45am on Sunday
11. Dogs must be kept on leads at all times.
12. Basic camping is available at venue from Friday evening, no water or petrol available.
13. All bikes must be refuelled in the start area (no petrol on the sections)
14. Please ensure all litter is put in the bins or taken home as this is grazing land.
15. Any protests must be made in writing to the secretary within 30 minutes of the last rider finishing with a fee of £50.








Directions to Sandfields Farm Cowden
