## Enrollment Agreement 2025-2026

---

By enrolling your child, you and Community Montessori School enter with mutual consent into the following agreement for enrollment for the 2025-2026 school year:

### TUITION & BILLING:

- Tuition is for a single school year. Tuition may be paid in a single installment or ten installments. Families opting for one installment will be billed on **August 1, 2025**. Families opting for ten installments will be billed on the 1st day of each month, beginning August 1, 2025 and continuing through May 1, 2026. Prorated tuition will be provided for families enrolling mid-year.
- Tuition and fees are non-refundable. There will be no tuition reduction or refund for any family situation, vacation, medical condition, force majeure event, suspension or expulsion from school for violation of school policies, or any emergency school closure that may cause a student to be absent from school.
- Tuition payments must be made through the Tuition Management System utilized by the school. Families can opt for ACH or credit card payments. Transaction fees are charged by the Service based on the option selected and these fees are not received by the school.

### ENROLLMENT FEES:

- A non-refundable enrollment fee is required to reserve a spot for your child in our program. Returning families are billed the re-enrollment fee on **March 1, 2025**. New families are billed the enrollment fee on **June 1, 2025** or upon their enrollment (if after June 1st).
- Trip transportation fees for Upper Elementary & Adolescent students are billed on **August 1, 2025** and are non-refundable. Overnight trips are an important developmental milestone and are part of our required curriculum at these levels. These trips are not considered optional.

### ADDITIONAL FEES:

- Enrollment in Before and After School Care is optional and is based on availability. Families enrolled are billed according to the rates on the Tuition & Fee Schedule at the time of service. Learning Support fees vary based on the services provided. Families enrolled will receive additional information (including rates) when they sign up. Summer Camp registration opens in January and fees are billed on June 1st and July 1st.
- Additional fees for school services or activities may be charged during the 2025-2026 school year when parents incur them. Examples include late pick-up fees, enrichment class fees, and yearbook purchases. Additional fees are billed through the Tuition Management System utilized by the school.

### LATE PAYMENTS OR FAILURE TO PAY:

- Tuition and fees owed are due on the 1st of the month. Missed payments are charged NSF and late fees by the Tuition Management System. Amounts unpaid by the 10th of the month are considered delinquent and will result in termination or suspension of enrollment. School records will not be released for students with outstanding balances.

### WITHDRAWAL FEES:

- Enrollment is for the entire 2025-2026 school year. Withdrawal fees are charged if parents terminate their child's enrollment at any time before the end of the school year in May, 2026. Note that withdrawals made before the school year begins are subject to withdrawal fees.
- The withdrawal fee is equal to 20% of your child's total annual tuition. If the withdrawal occurs during the school year, parents are responsible for paying a prorated amount of tuition for the days enrolled, in addition to the withdrawal fee.
