He tells her that he thinks the best thing for her to do is to work with the ESD#2 She says that she thinks the Agreement with Liberty is up in October. She does not want to renew with Liberty and work something out with the ESD#2. Johnny tells her that we would be glad to meet with her and discuss how an ESD works.

ITEMS FOR Discussion or Action:

1) HD-VFD Fire Suppression & Runs Report presented by Chief J.T. Smith. 69 Total runs in August. J.T. says that some of the grass fires is created by sun rays on glass objects. J.T. says that there are several things that the Fire Department needs. (4) black helmets, (2) Wye Ball Valve Swivel Rocker Lugs, (4) AV300 Full Facepiece (Fitted), (2) 1 ½" Turbojet Nozzle's.

Also, he says that we need to have a CPR First Aid Training for our Department. In 2024 we will have to address our Air Pack situation. Department is also in need of bottled water and Gatorade. He says that their badge machine is broken. Kelvin told him he knows where he can get the badges made for \$5-\$10 each. J.T. ask board to suspend Firefighter Curt Gartner for lack of participation. He ask that his gear be returned. Kelvin made motion to accept Run Report and review all of J.T's request . Fred made second. All in Favor. Motion Carried.

- 4) Touchstone District Service which we have taken on to inform public of Sales Tax Proposition for the ESD#2 would like to have an informal gathering at the Fire Station October 5th with the community. Have food and drinks and chance to mingle with the voters and possibly answer questions & inform them of the Sales Tax Proposition. Sonny made motion to set this up for the 5t October.
