HB 2601: Treasury Investment & Climate Protection Act



The Oregon Treasury has a fiduciary responsibility to protect all of Oregon's investments for the long term, including those in public employee retirement funds such as PERS. The current Treasury investment strategy leaves investments critically vulnerable to fossil fuel related climate risk.



Why do we need a bill? Oregon Treasurer Read publicly acknowledges a dangerous level of climate risk in Oregon's investments. Treasurer Read proposes creating a plan that continues supporting major climate destabilizers such as fossil fuel companies through 2050. The Climate Risk Assessment commissioned by the Treasury in 2021 shows investment in fossil fuels creates significant risk to PERS. Urgent action is required.

Fossil fuels are driving the climate crisis. Extreme weather, fires, and droughts devastate communities in Oregon and pose a risk to existing Treasury investments.



This bill stops risky NEW investments now. This bill also mandates the use of the Carbon Underground 200 list of companies, which the Treasury already uses as a filter.



Don't let Oregon be left holding the bag. The world is moving away from fossil fuels and toward clean energy. Investments in fossil fuel companies are risky and will be worthless.



The time to act is now.

Bill Overview

- 1. Immediate moratorium on new public and private carbon-intensive investments
- 2. Exit from carbon-intensive investments, using the Carbon Underground 200 list of companies, across all publicly traded OST funds, within 6 months
- 3. Exit from existing public investments in the largest identified coal, oil and natural gas producers and developers, using GOGEL and GCEL lists of companies, within 2 years
- 4. Exit from existing carbon-intensive private investments by 2035
- 5. Establish a portfolio-wide Climate Resilience Plan with an environmental justice framework
- 6. Require Treasury transparency and reporting to the public and legislature



The Oregon Treasury invests \$137 billion for the people of Oregon — at least \$5.3 billion in fossil fuels.
