# **PARENT/GUARDIAN & SPECTATOR CODE OF CONDUCT**

**We ALL have a responsibility to promote high standards of behaviour in the game.**

**This club is supporting The FA's Respect programme to ensure football can be enjoyed in a safe & positive environment.**

**Remember young people's football is an opportunity for them to develop their technical, tactical, physical, and social skills.**

**Always play your part in supporting your child and observe The FA's Respect Code of Conduct for spectators and parents/carers. As part of this process the club expects you to :-**

- **Remember that children play for FUN.**
- **Applaud effort and good play as well as success.**
- **Always respect the match officials' decisions whether you agree with them or not**
- **Remain outside the field of play and behind the respect barriers placed at the side of the pitch**

- **Let the coaches do their job and not confuse the players by shouting at or telling them what to do.**
- **Encourage the players to respect the opposition, referee and match officials.**
- **Stay behind the touchline and within the Designated Spectators' Area (where provided)**
- **Avoid criticising a player for making a mistake - mistakes are part of learning.**
- **Never engage in, or tolerate, offensive, insulting, or abusive language or behaviour.**
- **Remember our opponents are also young people & should be complimented on good play & conduct whilst on the pitch  
Parents, Guardians & spectators are representing the club & accordingly poor conduct reflects badly on the whole club.**

# **COACHES, TEAM MANAGERS & MATCH OFFICIALS CODE OF CONDUCT**

**Use your position to set a positive example for the people you're responsible for and lead a better game for everyone. On and off the field, I will:**

- **Always show respect to everyone involved in the game**
- **Stick to the rules and celebrate the spirit of the game**
- **Encourage fair play and high standards of behaviour**
- **Always respect the Referee and encourage players to do the same**
- **Never enter the field of play without the referee's permission**
- **Never engage in, or tolerate offensive, insulting or abusive behaviour**
- **Be aware of the potential impact of bad language on others**
- **Be gracious in victory and defeat**

- **Respect the facilities home and away**

**When working with players, I will:**

- **Place the well-being, safety and enjoyment of each player above everything**
- **Never tolerate any form of bullying**
- **Ensure all activities are suited for the players' ability and age**
- **Work with others (e.g. officials, doctors, welfare officers, physiotherapists) for each player's best interests**

**I understand that if I do not follow the Code, I may be:**

- **Required to meet with the club or league Welfare officer or your CFA Designated Safeguarding Officer (DSO).**
- **Suspended by the club from attending matches**
- **Suspended or fined by the County FA**
- **Required to leave, lose my position and/or have my license withdrawn**

# **YOUNG PLAYERS RESPECT CODE OF CONDUCT**

## **When playing football, I will:**

- **Always play to the best of my ability and for the benefit of my team**
- **Play fairly - I won't cheat, dive, complain or waste time.**
- **Respect my team-mates, the other team, the referee and my coach/team manager.**
- **Play by the rules, as directed by the referee**
- **Be gracious in victory and defeat - I will shake hands with the other team and referee at the end of the game**
- **Listen and respond to what my coach/team manager tells me**
- **Understand that a coach/team manager has to do what is best for the team and not one individual player**

- **Talk to someone I trust or the club welfare officer if I'm unhappy about anything at my club**

**I understand that if I do not follow the Code, any/all of the following actions may be taken by my club, County FA or The FA:**

### **I may:**

- **Be required to apologise to my team-mates, the other team, referee or team manager**
- **Receive a formal warning from the coach/team manager or the club committee**
- **Be dropped or substituted**
- **Be suspended from training In addition:**
- **My club, County FA or The FA may make my parent or carer aware of any infringements of the Code of Conduct**
- **The FA/County FA could impose a fine and suspension against my club**
