UPSTART NORTH EASTON SAVINGS BANK WINS SSCAC’S MARCH MANIA FOOD DRIVE

SSCAC’S 2nd Annual March Mania Food Drive Tournament Delivers Another Slam Dunk for the Community.



[PLYMOUTH] It was peanut butter & jelly time during the final week of competition, pitting tournament rookies North Easton Savings Bank and the Plymouth Elks Club against each other for SSCAC’s coveted John van Hengel March Mania Championship Trophy. North Easton Savings Bank came into the game heavily favored as the tournament’s leading point getter, but the Plymouth Elks were not deterred. This is why you play the game—anything can happen. It came down to the wire, but North Easton Savings Bank’s late week push cemented their victory, outscoring the Elks 3,710 to 3,222. The Plymouth Elks have nothing to be ashamed

of; they had a great tournament, just coming up a little short in the end.

THE ROAD TO THE FINALS: FINAL FOUR RECAP

With cans of fruit, pasta, and hearty stews worth extra points during the Final Four, the Plymouth Elks (Region 3) knew they would have to press to beat the Silver Lake National Honor Society squad (Region 4). It was a tough match-up with multiple scoring changes, but the Elks defeated the Honor Society by a “below-average student SAT score”—1,100 to 878.

In the second Featured Match-Up, two “big money” teams squared off: Rockland Trust (Region 1) against North Easton Savings Bank (Region 2). Rockland Trust went deep last year, and many brackets had them advancing to the Title Game. However, the Cinderella story continued for North Easton Savings Bank, who shocked the world with a 3,584 to 2,437 victory.
