

# **Warehouse Data Entry Crew Member (Full-time)**

The Loaves & Fishes Warehouse is often the first point of contact for donors bringing in-kind donations that support all programs and for some, their first experience on our campus. In addition to accepting in-kind donations of food and other supplies, the Warehouse team is also responsible for data entry, inventory management, food & supply ordering, donation distribution to our programs, and warehouse maintenance.

The Warehouse Data Entry Crew Member is a full-time, non-exempt position that reports to the Finance Director and is one of five members on the team. The Data Entry Crew Member is primarily responsible for maintaining the integrity of all inventory systems, entering data for each transaction on a daily basis, creating purchase orders and managing contact with vendors. This position also assists other Crew Members with accurate inventory documentation, receiving and distributing donations, warehouse maintenance, offering assistance to the other Loaves & Fishes programs when needed.

Loaves & Fishes Mission Statement: In an environment of welcome, hospitality, safety, and cleanliness we seek to provide an oasis for homeless men, women and children seeking survival services.

## Position responsibilities:

- Process and enter all daily transactions whether purchased or in-kind
- Generate purchase orders and donor receipts as needed
- Participate in monthly and annual physical inventory counts and reconciliation
- Report accurate monthly inventories to Finance Director
- Maintain First In, First Out (FIFO) method of distributing inventory
- Assist with maintaining Equipment and Safety logs at all times
- Comfortable with daily interactions, speaking with donors & vendors about organizational needs
- Receive donations, stock shelves, pull & deliver program orders as needed
- Assist in recording and distributing donations according to Finance Director's instructions
- Warehouse maintenance, cleaning and compliance with Cal OSHA requirements
- Other duties as assigned

# Required skills and Qualifications:

- Excellent computer skills with Microsoft Word, Excel & Access database are required; non-negotiable
- Must have excellent math skills with written and verbal communication skills
- Must be detail oriented
- Must be familiar with inventory processes & documentation
- Must be familiar with Cal OSHA requirements
- Must have the ability to work independently and as part of a team
- Must be able to follow instructions and receive constructive criticism
- Willing and able to engage with the public in-person, by phone and email

- Ability to exhibit a professional and courteous demeanor toward guests, donors, staff, and volunteers at all times
- Ability to maintain personal and professional boundaries
- Demonstrate a commitment to Loaves & Fishes' mission and philosophy
- Experience with food handling is a plus; certification required
- Must be able to work in a fast-paced environment and meet critical deadlines
- Prior warehouse experience preferred

#### **Physical Requirements:**

- Ability to sit, walk, stand, bend, squat, climb, kneel, and twist on an intermittent or sometimes continuous basis
- Ability to grasp, push, and/or pull objects
- Must be able to lift 30-50 lbs, without limitations

### Other Requirements:

- Must be able to work holidays & weekends as needed but especially from November to January
- Must have valid CA Driver's License and a clean driving record
- Food Handler's Certification is required
