<b>COMPLETE CEREMONIAL SERVICE AT FUNERAL HOME OR CHURCH</b>		<b>\$5590</b>
<p>This charge includes the services of funeral director and staff, transfer of remains to funeral home within 25 miles, embalming, other preparation of the body, use of facilities for viewing and funeral ceremony or services in another facility and automotive equipment, within 25 miles. The casket and vault and other merchandise selected by you will be added to this price, plus cash advanced to others and State Sales Tax.</p>		
<b>VISITATION WITH CEREMONIAL SERVICE AT GRAVESIDE</b>		<b>\$5295</b>
<p>Same as above except ceremony is at graveside only and there is no procession.</p>		
<b>CEREMONIAL SERVICE, THEN CREMATION</b>		<b>At Funeral Home \$5340</b>
<p>This charge includes the services of funeral director and staff transfer of remains to funeral home within 25 miles, embalming, other preparation of the body, use of facilities for viewing and funeral ceremony or services at another facility, automotive equipment within 25 miles, cremation and authorizations. The casket and other urns or merchandise selected by you will be added to this price, plus other cash advanced to others and State Sales Tax. Cremation of deceased over 250lb may incur additional crematory and transport charges.</p>		
<b>CREMATION, THEN CEREMONIAL SERVICE</b>		<b>At Funeral Home \$4440</b>
<p>Same as above except no embalming and no other preparation of the body. Refrigeration is required after 48 hours and will be added.</p>		
<b>FORWARDING REMAINS TO ANOTHER FUNERAL HOME</b>		<b>\$2655</b>
<p>This charge includes removal of remains, services of staff, necessary authorizations, embalming and local transportation. It does not include other staff services or use of facilities needed for viewing or visitation or ceremonies prior to forwarding the body. Merchandise, cash advanced to others and State Sales Tax will be added to this price.</p>		
<b>RECEIVING REMAINS FROM ANOTHER FUNERAL HOME</b>		<b>\$3145</b>
<p>This charge includes necessary services of staff, care of remains and transportation of remains from airport to funeral home, then to cemetery or crematory. It does not include other staff services or use of facilities for viewing or visitation or ceremonies prior to the graveside service.</p>		
<b>DIRECT CREMATIONS</b>		<b>\$2845 to \$9241</b>
<p>Our charge for a direct cremation (without ceremony) includes cremation, removal and shelter of remains for 48 hours and transportation to crematory and necessary services of staff and authorizations. State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without outside covering). The containers we provide are reinforced cardboard containers. Refrigeration is required after 48 hours and will be added.</p>

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Certain funeral services may be provided off-premises by other funeral service providers.

### PROFESSIONAL SERVICES

Basic services of funeral director and staff \$2,400

Our charge for the funeral director and staff includes, but is not limited to twenty-four hour availability of staff to respond at the time of death; consultation with those responsible for the funeral and others, including coordinating with those providing other portions of the funeral, such as clergy and cemetery; procurement, preparation and filing of death certificate, necessary notices, authorizations, consents and permits; general administration and record keeping, other general expenses and supervision of basic activities; sheltering of remains, recording and reporting vital statistics, preparation and placement of obituary notice. Also included in this charge are overhead expenses relative to our building and equipment, professional licensing, legal and accounting fees, insurance, utilities, grounds, maintenance, taxes, equipment, furnishings and inventory costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, forwarding or ceremonial service at graveside, and cremation followed by ceremonial service.)

Embalming \$600

Embalming is not required by law. Embalming may be necessary, however if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Other preparation of the body \$300

This includes cosmetology, grooming, casketing; and restoration (when possible) if needed.

**TRANSFER OF REMAINS TO FUNERAL HOME** \$495

This charge is for the personnel and the vehicle used to initially bring the remains to the funeral home, if within 25 miles. If additional staff is needed because the weight of the deceased exceeds 250 pounds, an additional fee of \$100 will apply.

**PLEASE NOTE:** All transportation charges are local within a 25 mile radius. If beyond our local area, we charge \$3.00 per loaded mile for the hearse or \$2.75 per loaded mile for other vehicles, in addition to the local charge.

**OUTER BURIAL CONTAINERS:** \$2723 to \$1995  
A complete list will be provided at the funeral home. In most areas of the country, state or local law does not require you to buy a container to surround the casket in the grave. However, many cemeteries require that you have a container so that the grave will not sink in. Either a burial vault or a grave liner will satisfy these requirements

### Digital Direct Cremation

Our digital direct cremation allows you to complete the authorizations for cremation, provide information for the death certificate, and to make secure digital positive identification of your loved one all from the comfort of your own home. You can select urns and keepsakes to honor your loved one as well as order death certificates. Our digital option includes all of the same professional services of our directors and staff that our direct cremation option offers. Our staff will be available to assist you with scheduling with cemeteries, writing obituaries, and requesting military honors and benefits.

Please note the digital arrangement system charges a processing fee for online payments. Cash or Check payments in person can still be made to forgo the processing fee.

\*Shipping of cremated remains is not included in direct cremation pricing and may only be done by USPS Priority Express Mail. The cost for shipping and handling cremated remains within the lower 48 states is \$150.

**Anatomical Donation Assistance** Transfer of remains within 25 miles, filing of death certificate, and refrigeration for up to 24 hours. **\$1190**

*If the deceased is not accepted by the state anatomical program and we provide cremation services, these charges are applied towards the cremation cost not in addition to them.*

### Stillborn, Infants, and Children

The funeral home management at their discretion may offer discounts to families experiencing the loss of a child. For cremation services of children all state required permit fees still apply.

### URNS AND KEEPSAKE JEWELRY

The funeral home reserves the right to refuse to fill keepsake urns and keepsake jewelry purchased from outside retailers due to liability of damage and or replacement.

### CEMETERY COSTS

Charges for opening and closing the grave vary depending upon the cemetery. Some cemeteries do not include the cost of the tent, chairs and special equipment in their fee, so these items must be rented. If not already reserved, it will be necessary to purchase the grave space at the time of the funeral (unless burial will be in a National Cemetery or state veterans cemetery).

### OTHER

Other items of cost may include copies of the death certificate, obituary notices and sometimes honoraria for the clergy and others. Additionally, there might be expenditures for burial clothing, monuments and out of town transportation, etc.

These are known as cash advances because you reimburse us what we pay the provider.

The City of Hampton requires a \$100.00 fee to provide a police escort, which is required for all funeral processions. The City of Newport News charges \$204 for the funeral escort. You reimburse us for this.

Holding, Care, and Supplies for burial of casketed remains in Arlington National Cemetery or other cemeteries, delayed more than 30 days will require a \$1000 charge.

Costs of out of town interments may vary depending on transportation costs and type of service.

If Death Certificate information is provided incorrectly and amendments are needed to correct it, the family is responsible for court costs, reasonable attorney fees, and transportation costs as well as the \$12 per copy charge for replacement death certificates paid to the state of Virginia.

**Viewing of the un-embalmed deceased for positive identification is by immediate family member or designee only.**

**Refrigeration required for all un-embalmed deceased.**

**The crematory may have additional charges for deceased that exceed 250 pounds.**
