This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

The plans may be purchased at 1724-B 23rd Avenue, Meridian, MS 39301 at a cost of Fifty Dollars (\$50) Non-Refundable for the Plans and a cost of Fifty Dollars (\$50) Non-Refundable for the Contract Documents. The population of this county is less than 20,000.

Certified check or bid bond for five percent (5%) of the total bid, made payable to Noxubee County and the State of Mississippi must accompany each proposal.
