The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director & Staff.....\$595

Our fee for the services of funeral director and staff includes, but is not limited to: staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory, and others. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

Embalming.....\$695

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Charge for Extra Man on a Removal (for non-facility removal).....\$ 50

Use of Equipment and Staff for visitation/viewing at church, graveside, or location of your choice.....\$199
For 2 hours visitation same day as the funeral or graveside service.

Use of Equipment and Staff for visitation/viewing at church, graveside, or location of your choice.....\$398
We will arrange for and be in attendance. Facility charges may apply if so charged by location.

Use of Equipment and Staff for Memorial Service.....\$398
We will arrange for and be in attendance at a memorial service at a location you select, during regular business hours*. This allows you to have a designated time for family and friends to gather in remembrance following the cremation process. Cemetery charges not included.

Use of Equipment and Staff for Traditional Funeral Service at Church.....\$398
We will arrange for and be in attendance at a funeral service at your church or other location, during regular business hours.*

Use of Equipment and Staff for Traditional Graveside Funeral Service.....\$398
We will arrange for and be in attendance at a funeral service at the graveside, during regular business hours.* Cemetery charges not included.

****Regular business hours are commonly recognized as Monday through Friday,
8:00 AM – 5:00 PM, excluding normal holidays.***

An additional fee applied to services outside regular business hours.....\$295

Forwarding of remains to another funeral home.....\$1,475

Our charges include basic services of funeral director & staff, proportionate share of overhead cost, removal of remains, embalming & other preparations of remains, and transportation to Nashville Airport.

Excludes shipping charges

NOTE: The casket of your choice may be used for forwarding the deceased to another funeral home. Additional charge of \$195.00 for a Casket Air Tray may be needed when shipping by air. If no casket is selected a combination air tray for air shipment must be purchased.

Receiving remains from another funeral home..... \$1,275

Our charges include basic services of funeral director & staff, proportionate share of overhead cost and removal of remains from Nashville Airport to funeral home or crematory.

Direct Cremation.....\$995-\$3,280

Our charge for a direct cremation (without ceremony) includes: Basic Services of Funeral Director and Staff and Overhead, Transfer of Remains to Crematory, Crematory Charge, and Temporary Container (urn). **All prices are valid up to 400lb.**

(Note: State Cremation Permit of \$25.00 NOT included)

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a corrugated leak-proof container.

- A. Direct Cremation with container provided by the purchaser.....\$ 995
- B. Direct Cremation with corrugated leak-proof container\$ 1,120
- C. Direct Cremation with family identification and corrugated container (immediate family only/limited to 10 people – During regular business hours only (autopsy and tissue donor exempt)).\$1,415

Immediate Burial.....\$1,695-\$ 4,685

Our charge for an immediate burial (without embalming or ceremony) includes: Basic Services of Funeral Director and Staff and Overhead, Removal of Remains to Funeral Home, Washing and Disinfection of Un-embalmed Remains, Dressing, and local transportation to cemetery. Does not include opening & closing of grave, outer burial container, cemetery charges or casket.

A. Immediate burial with casket provided by the purchaser \$1695

B. Immediate burial with casket purchased from funeral home.....\$2,990 - \$4,685
(Price of option A, plus cost of casket selected)

Up to 10 family members can attend the identification viewing. The Crossover cremation container is recommended for this option.) (Not applicable for autopsy and tissue donor cases)

(This fee is for submitting the obituary to your newspaper(s) of choice. This price is in addition to the newspaper's fee, which varies depending on their rates and the size of the obituary.)
