Facts

The Court previously continued this matter and permitted the filing of supplemental declarations as to the lodestar information to calculate attorneys' fees and information as to the presently incurred costs. On December 1, 2023, Plaintiff's counsel filed additional declarations as to these issues.

Attorneys' Fees and Costs

Attorneys' fees of 35% of the gross settlement fund of \$585,000 or \$204,750 and costs not to exceed \$20,000 are sought by Plaintiff's counsel.

Counsel has utilized the percentage of common fund methodology as well as provided adequate lodestar information to evaluate the reasonableness of the fee request.

Here, Counsel Minne indicates that Parker & Minne, LLP has spent 212.3 hours at a rate from \$725 per hour, providing a lodestar for the firm of \$153,917.50. (Declaration of Minne ¶¶11-13.) The Court will not include the forty (40) anticipated hours in its calculation of the lodestar, but notes that counsel may submit, with the motion for final approval, a declaration updating the hours incurred in this matter.

Additionally, counsel Smith indicates that Smith Law has spent 27.1 hours at a rate of \$750 per hour, resulting in a lodestar of \$20,325. (Declaration of Smith ¶4.)

Therefore, the total lodestar in this matter is presently at \$174,242.50. This would require the Court to utilize a multiplier of 1.18, within the range of multipliers the Court typically approves.

Counsel Minne indicates presently incurred costs of \$11.57. (Declaration of Minne ¶24) Counsel Smith indicates presently incurred costs of \$8,495.70. (Declaration of Smith ¶5.) The Court preliminarily approves costs not to exceed \$20,000.00.

Therefore, Plaintiff's deductions from the gross settlement of \$585,000 are preliminarily approved as follows:
