In accordance with, and for the reasons stated in the Order Granting Final Approval of Class Action Settlement, judgment shall be entered whereby Plaintiff Erlinda Prado and all Settlement Class Members shall take nothing from Defendants Laurel Canyon Dialysis, LLC, American Renal Care, LLC, Parag Shah and Omaran Abdeen except as expressly set forth in the Class Action and PAGA Settlement Agreement, which was previously filed as part of Plaintiff’s Motion for Preliminary Approval of Class Action Settlement, which was granted on January 26, 2026.

As stated in the Order Granting Final Approval of Class Action Settlement, the gross settlement amount is \$440,000 and the net amount to be distributed to the Class Members is ~~\$249,128.76~~ <sup>\$251,628.76</sup>. The Court also awards the following: (1) \$146,666.67 for attorney’s fees; (2) \$17,954.57 in attorneys’ costs; ~~(3) \$10,000 to~~ <sup>\$7,500</sup> the Plaintiff as an incentive award; (4) \$6,250 for settlement administration costs; (5) \$6,500 to California’s Labor & Workforce Development Agency for the settlement of alleged penalties under the California Labor Code’s Private Attorneys General Act of 2004 (“PAGA”); and (6) \$3,500 to be distributed to the Aggrieved Employees.

Pursuant to Code of Civil Procedure section 664.6 and Rule 3.769(h) of the California Rules of Court, the Court reserves exclusive and continuing jurisdiction over this Action, Plaintiff, the Class Members, and Defendants for the purposes of:

- (a) supervising the implementation, enforcement, construction, and interpretation of the Class Action and PAGA Settlement Agreement, the Order Granting Preliminary Approval of Class Action Settlement, the plan of allocation, the Order Granting Final Approval of Class Action Settlement, and the Judgment; and
- (b) supervising distribution of amounts paid under this Settlement.
