3 **TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

4 On March 2, 2026, the Court entered an Order which granted Plaintiff's Motion for
5 Preliminary Approval of Class and Representative Action Settlement, granted conditional class
6 certification, approved the format of the Class Notice, and set a Final Approval Hearing (the
7 "Preliminary Approval Order"), thereby preliminarily approving a settlement of the above-entitled
8 action (the "Action") that was reached between Plaintiff Ararat Aghajanian ("Plaintiff") and
9 Defendant Fastener Technology Corp. ("Defendant") (together with Plaintiff, the "Parties"), in
10 accordance with the Parties' Class Action and PAGA Settlement Agreement and Class Notice (the
11 "Settlement"). The Settlement is attached as **Exhibit 1** to the Declaration of Kane Moon in Support
12 of Plaintiff's Motion for Final Approval of Class and Representative Action Settlement.

13 The Court has entered an Order granting final approval of the Parties' Settlement (the "Final
14 Approval Order"). The Court now has before it a [Proposed] Judgment.

15 The Court, having entered a Final Approval Order in this Action, and good cause appearing,

16 **HEREBY ADJUDGES AND DECREES AS FOLLOWS:**

17 1. The Court, for purposes of this Judgment, refers to all terms and definitions as set
18 forth in the Settlement.

19 2. The Court enters Judgment as follows: Plaintiff, Class Counsel, the Class Members,
20 the PAGA Members, the California Labor and Workforce Development Agency, and the
21 Administrator shall take nothing from Defendant except as expressly set forth in the Final Approval
22 Order and according to the terms of the Settlement.

23 3. The Parties shall bear their own respective attorneys' fees and costs, except as
24 otherwise provided for in the Settlement and approved by the Court.

25 4. This Judgment and the concurrently filed Final Approval Order are intended to be a
26 final disposition of the Action in its entirety and are intended to be immediately appealable.

27 5. Notwithstanding the finality of this Judgment, pursuant to California Rules of Court
28 Rule 3.769, *et seq.* and California Code of Civil Procedure section 664.6, the Court shall retain

1 jurisdiction over the Parties, Action, and the Settlement solely for purposes of (i) enforcing the
2 Settlement and/or Judgment, (ii) addressing settlement administration matters, and (iii) addressing
3 such post-Judgment matters as are permitted by law.

4 **IT IS SO ADJUDGED.**
