~~PROPOSED~~ ORDER GRANTING PRELIMINARY APPROVAL OF CLASS AND REPRESENTATIVE ACTION SETTLEMENT

IT IS HEREBY ORDERED:

1. The Court grants preliminary approval and conditional certification of the Class;
2. The Court grants preliminary approval of Plaintiff Daniella Lopez as Class Representative;
3. The Court grants preliminary approval of Otkupman Law Firm, A Law Corporation, as Class Counsel;
4. The Court grants preliminary approval of Settlement of claims as set forth in the Settlement Agreement;
5. The Court approves the proposed Class Notice and Exclusion Form;
6. The Court grants preliminary approval of the Gross Settlement Amount of \$275,000.00;
7. The Court grants preliminary approval of ILYM Group, Inc. (“ILYM”) as Settlement Administrator and payment of service in an amount up to \$20,000.00 and currently estimated to be \$6,000.00;
8. The Court grants preliminary approval of a Class Representative Enhancement Payment to Plaintiff Daniella Lopez in an amount up to \$10,000.00; subject to proof of plaintiff's contributions towards pursuing the class action,
9. The Court grants preliminary approval of the payment to Class Counsel of reasonable attorney's fees of \$96,250.00 and costs up to \$20,000.00; subject to a showing that the fees and costs are reasonable and fair.
10. The Court grants preliminary approval of the PAGA Payment in the amount of \$25,000.00, and of the proposal to pay 75% of this amount ~~will be paid~~ to the LWDA and 25% of this amount ~~will be paid~~ to the PAGA Members on a pro rata basis.
11. The Court ^{preliminarily} approves the amounts as set forth in the table below; subject to further proof:
