YOU ARE HEREBY NOTIFIED THAT at 1:30 p.m. on November 8, 2024, or as soon thereafter as the matter can be heard, in Department CX103 at the above entitled Court before the Honorable Lon Hurwitz, Plaintiffs Manuel Franco and Alfonso Guzman ("Plaintiffs") will apply for an order: (1) preliminarily approving the proposed settlement of this class action with Defendant States Logistics Services, Inc.
