TO THE COURT, TO ALL PARTIES, AND TO THEIR RESPECTIVE ATTORNEYS OF RECORD:

WHEREAS, on August 11, 2023, the Court granted preliminary approval of the class action settlement between Plaintiff Teri Flores ("Plaintiff") and Janesri De Silva M.D., a Professional Corp. ("Defendant") (collectively, the "Parties");

WHEREAS, at the August 11, 2023 hearing, the Court set a deadline for delivery of the class list to the Settlement Administrator for September 1, 2023 and additional deadlines based on the delivery of the class list;

WHEREAS, Defendant failed to produce the class data to the Settlement Administrator by September 1, 2023;

WHEREAS, the failure to produce the class data was a result of, among other things, a deterioration of the attorney-client relationship between Defendants and their former counsel of record, Offit Kurman;

WHEREAS, new counsel for Defendants substituted into the case on December 4, 2023, and are working with Defendants to finalize the class list;

WHEREAS, in light of the delay, the Parties request the delivery of the class list and all related deadlines be continued to allow for time to mail the class list and for Plaintiff to prepare her motion.

THEREFORE, IT IS HEREBY STIPULATED by and between the attorneys for the Parties that:

The Final Approval Hearing and related deadlines shall be continued as follows:

- 1) Defendant must produce the class information to the administrator no later than January 16, 2024.
- 2) The Class Notices must be mailed no later than January 29, 2024.
- 3) Any opt-outs or objections to the Settlement are due no later than March 29, 2024.

4) Plaintiff must file her motion and request for attorneys' fees no later than February 29	
2024.	
5) An administrator report must be filed no later than April 18, 2024.	
6) A Final Fairness and Approval hearing shall be held before this Court on April 29, 2024	
at 9:00 a.m.
