GRANTING PRELIMINARY
APPROVAL OF CLASS ACTION
SETTLEMENT**

1 WHEREAS, the above-entitled action is pending before this Court as a putative class
2 action (the “Action”);

3 WHEREAS, Plaintiff Baltazar Perez (“Plaintiff”), individually and on behalf of all others
4 similarly situated and on behalf of the general public have applied to this Court for an order
5 preliminarily approving the settlement of the Action in accordance with the CLASS ACTION
6 AND PAGA SETTLEMENT AGREEMENT AND CLASS NOTICE (the “Settlement” or
7 “Agreement”) entered into by Plaintiff and Defendants AAA Facility Services, Inc.; AAA
8 Electrical & Communications, Inc. (“Defendants”) which sets forth the terms and conditions for
9 a proposed settlement upon the terms and conditions set forth therein (Plaintiff and Defendants
10 shall be collectively referred to herein as the “Parties”); and

11 WHEREAS, the Court has read and considered Plaintiff's Motion for Preliminary
12 Approval of Class Action Settlement.

13 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED
14 THAT:

15 1. This Order incorporates by reference the definitions in the Settlement attached as
16 Exhibit 1 to the Declaration of Jamie M. Loos in Support of Plaintiff’s Motion for Preliminary
17 Approval of Class Action Settlement and all terms defined therein shall have the same meaning in
18 this Order.

19 2. It appears to the Court on a preliminary basis that (a) the Settlement is fair,
20 adequate and reasonable; (b) the Gross Settlement Amount and Net Settlement Amount are fair,
21 adequate and reasonable when balanced against the probable outcome of further litigation relating
22 to liability and damages issues; (c) sufficient investigation and research have been conducted such
23 that counsel for the Parties at this time are able to reasonably evaluate their respective positions;
24 (d) settlement at this time will avoid additional costs by all Parties, as well as avoid the delay and
25 risks that would be presented by the further prosecution of the Action; and (e) the Settlement has
26 been reached as the result of non-collusive, arms-length negotiations.

27 3. With respect to the Class and for purposes of proceeding pursuant to California
28 Code of Civil Procedure § 382 for approval of the settlement only, the Court finds on a

1 preliminary basis that (a) Class Members are ascertainable and so numerous that joinder of all
2 Class Members is impracticable; (b) there are questions of law and fact common to the Class that
3 predominate over any questions affecting only individual Class Members; (c) Plaintiff's claims
4 are typical of the Class's claims; (d) class certification is a superior method for implementing the
5 Settlement and adjudicating this Action in a fair and efficient manner; (e) the Class
6 Representatives can fairly and adequately protect the Class's interests; and (f) Class Counsel are
7 qualified to serve as counsel for the Class.

8 4. Accordingly, solely for purposes of effectuating this Settlement, this Court hereby
9 conditionally certifies the class for settlement purposes only. The Class is defined as all California
10 citizens currently or formerly employed by Defendants as non-exempt employees in the State of
11 California at any time during the period of December 13, 2021 to August 27, 2024, excluding
12 employees whose claims were released in the class action settlement in the case of *Alvarado v. AAA*
13 *Electrical Communications, Inc.* in Los Angeles County, Case No. 19STCV46461 only as to
14 their claims released during the class period ending December 13, 2021.

15 5. Plaintiff Baltazar Perez is hereby preliminarily appointed and designated, for all
16 purposes, as the Class Representative and the attorneys of Aegis Law Firm, PC are hereby
17 preliminarily appointed and designated as counsel for the Class ("Class Counsel"). Class Counsel
18 is authorized to act on behalf of the Class Members with respect to all acts or consents required by,
19 or which may be given pursuant to, the Settlement, and such other acts reasonably necessary to
20 consummate the Settlement. Any Class Member may enter an appearance either personally or
21 through counsel of such individual's own choosing and at such individual's own expense. Any
22 Class Member who does not enter an appearance or appear on his or her own will be represented
23 by Class Counsel.

24 6. Should, for whatever reason, the Settlement not become final, the fact that the
25 Parties were willing to stipulate to certification of the Class as part of the Settlement shall have no
26 bearing on, nor be admissible in connection with, the issue of whether a class should be certified in
27 a non-settlement context.

1 7. The Court hereby preliminarily approves the definition and disposition of the Gross
2 Settlement Amount and Net Settlement Amount and related matters provided for in the Settlement,
3 subject to modification at final approval.

4 8. The Court hereby preliminarily approves Class Counsel attorneys' fees of up to one-
5 third the Gross Settlement Amount, Class Counsel litigation expenses not to exceed \$25,000.00,
6 Service Award up to \$7,500.00 to the Plaintiff, payment to the LWDA in the amount of
7 \$15,000.00, and costs of administration not to exceed \$6,750.00, subject to final approval.

8 9. The Court hereby approves, as to form and content, the Class Notice, to be
9 distributed to Class Members. The Court finds that distribution of the Class Notice, substantially in
10 the manner and form set forth in the Settlement and this Order, meets the requirements of due
11 process, is the best notice practicable under the circumstances, and shall constitute due and
12 sufficient notice to all persons entitled thereto.

13 10. The Court hereby appoints ILYM Group, Inc. as Settlement Administrator and
14 hereby directs the Settlement Administrator to mail or cause to be mailed to Class Members the
15 Class Notice using the procedures set forth in the Settlement Agreement. Class Members who wish
16 to participate in the settlement provided for by the Settlement Agreement do not need to respond to
17 the Class Notice.

18 11. All costs of mailing of the Class Notice, whether foreseen or not, shall be paid
19 from the Gross Settlement Amount, including the cost of searching for Class Members' addresses
20 as provided in the Settlement, and all other reasonable costs of the Settlement Administrator up
21 to \$6,750.00 as provided in the Settlement.

22 12. Any Class Member may choose to opt-out of and be excluded from the Class as
23 provided in the Class Notice. Any such person who chooses to opt-out of and be excluded from the
24 Class will not be entitled to any recovery under the Settlement and will not be bound by the
25 Settlement or have any right to object, appeal or comment thereon. Class Members who have not
26 requested exclusion/opted-out shall be Participating Class Members and bound by all
27 determinations of the Court, the Settlement, and the Final Judgment.

1 13. A Final Fairness and Approval Hearing shall be held before this Court on ~~October~~
2 ~~20, 2025 at 9:00 a.m.~~ in Department 7 of the Superior Court for the State of California, County of
3 Los Angeles, located at 312 North Spring Street, Los Angeles, CA 90012. All papers in support of
4 final approval and related awards for fees, costs, and Plaintiff's incentive award must be filed and
5 served at least 16 court days before the final approval hearing.

6 14. Any Participating Class Member must object to the Settlement by following the
7 instructions for submitting written objections that are set forth in the Settlement Agreement and
8 Class Notice, and may appear at the Final Fairness and Approval Hearing. The Court shall retain
9 final authority with respect to the consideration and admissibility of any objections. Any
10 Participating Class Member who objects to the Settlement shall be bound by the order of the Court.

11 15. The Settlement is not a concession or admission, and shall not be used against the
12 Released Parties, as an admission or indication with respect to any claim of any fault or omission
13 by the Released Parties. Whether or not the Settlement is finally approved, neither the Settlement,
14 nor any document, statement, proceeding or conduct related to the Settlement, nor any reports or
15 accounts thereof, shall in any event be construed as, offered or admitted in evidence as, received as
16 or deemed to be evidence of a presumption, concession, indication or admission by Defendants of
17 any liability, fault, wrongdoing, omission, concession or damage in the Action, or in any other
18 action or proceeding, except for purposes of enforcing the Settlement once it receives final approval.

19 16. Pending the Final Approval and Fairness Hearing, all proceedings in this Action,
20 other than proceedings necessary to carry out or enforce the terms of the Settlement and this Order,
21 are hereby stayed.

22 17. Jurisdiction is hereby retained over this Action, the Parties to the Action, and each
23 of the Class Members for all matters relating to this Action, and this Settlement, including
24 (without limitation) all matters relating to the administration, interpretation, effectuation, and/or
25 enforcement of this Settlement and this Order.
