If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the remains and can be made of materials like fiberboard or composition materials (with or without an outside covering).

The containers we provide are fiberboard cremation containers.

Note: Iowa code requires that no crematory shall accept human remains unless they are delivered to the crematory in a container, which prevents exposure to any biohazards.*
