Association Traffic Survey Complete

The Crestwood Association board created a survey about traffic calming on N. Bailey Road at the reques of residents in the 300-500 block of N. Bailey. The results have been tallied. Per city requirements we have enough support from this survey for the city to initiate a study.

Here's a very brief summary of the survey:

Residents were asked to indicate their support for either Option 1 (Keep the current level of traffic calming) or Option 2 (Add additional traffic calming features).

Total number of household responding = 89. Of the Crestwood residences, 69 of 89 were in favor of Option 2 (additional traffic calming) (78%)

N. Bailey residents in particular were in favor of Option 2 by 82% of respondents.

Typical traffic calming features in Fort Worth have been speed humps and/or stop signs.

Residents offered many suggestions for traffic calming features besides speed humps and stop signs.

All comments submitted have been logged for the city review.

Further action will only be taken after the street construction is done. The humps currently affixed in the 400 block of N. Bailey will not be replaced. The street project is expected to take between 18 months and two years. And the first thing the city will do after project completion is their own analysis of speeds on N. Bailey. In the meantime, our new NPO Officer Back has stated he will issue tickets for speeding as he encounters it.

Skunk Invasion

Neighbors on Lindenwood Dr. are experiencing a skunk invasion. In **one week** in September; 11 skunks were removed by the city. This is a reminder to stop feeding neighborhood wildlife. The feral cats have plenty to eat without leaving food out and the skunk and rat population do not need our help.

Phase Two of the Water and Sewer lines replacement commenced

September 9th. Things to know about phase 2: From September 2025 the project is expected to last 18-24 months. Construction will start on North Bailey, followed by Lindenwood, and Crestwood Terrace. (Crestwood Dr., Cresthaven Terr. and Ridgewood.) To learn how you might be specifically impacted please visit www.fortworthtexas.gov and type in 103362 in the search menu and you will find a project entitled "North Bailey - Lakewood to White Settlement - Water and Sewer". All information is there. Of note, you will get hangtags twice before you are impacted by the work. If you have any problems call Clayton Tor-



rance 817-392-8528 or Nakia McCain 817-319-6130. In emergency call 817-392-4477. Call immediately if your water is not turned back on when promised. Road resurfacing is also part of the project. Crews will help with your trash bins if you can't get them across the street from construction and the city will manage pickup as well.

Three generations of Kirks have called Crestwood home. For Wesley and his wife Amanda Reyes, Crestwood is where they want to raise their family too. Wesley and Amanda are a fixture in the Fort Worth Performing and Visual Arts scene. Amanda has acting credits to her name in Los Angeles and New York as well as theaters in the metroplex. She is taking on her first directorial role in Dallas at the Bath House Cultural Center in White Rock Lake Park on Lawther, in a play adapted from King Lear entitled "El Rey del Pollo" which runs through the 27th of September. Wesley wears many hats including running a production company Vision & Verve, Support Fort Worth Art (a non-profit that engages the city of Fort Worth to nurture the arts scene), as well as being the development manager for Amphibian Stage, and the 817 Podcast producer. He sits on three boards relat-

home around had a playmate with whome he went to school with North Hi Mount Elementary. When he and his friends weren't roaming the streets on bikes and taking over the neighborhood just after school, they were in the woods just to the east of the neighborhood building forts and tree houses and exploring. In his time wild turkey, pig, deer, and armadillos were common sites wandering down North Bailey, or crossing the meadow to the east. The fracking to the east of the woods sent most of these forest denizens away. Wesley also remembers biking along the Trinity all the way to Panther Island on many visits to the ruins at La Corte Barrio on the bluffs overlooking the Trinity River – a nearly 8 mile round trip. This type of excursion "back in the day" made possible by the "we'll see you when you get home" parenting that many raised before the mid1990s experienced! What an adventure!

Wesley commented on his pride in what the Crestwood Community has become - while he and Amanda nurture new friendships and reestablish old ones around the neighborhood through various social and community events. I think many of us share his pride in Crestwood – the greatest neighborhood secret in Fort Worth. Shhh! Don't tell anyone.
