In November 2022 Colorado voters voted to support Proposition 123, a large and sustained financial investment to meet the affordable housing needs of Colorado communities.

The Grove at Cottonwood Update

BHA, in partnership with Caddis Collaborative, has submitted a development review application to the City and County of Broomfield for The Grove at Cottonwood housing development. The Grove will offer 40 affordable rental homes and is being designed to serve the specific needs of individuals with intellectual or developmental disabilities (I/DD) and older adults. BHA Awarded Department of Local Affairs Technical Assistance Grant

The Department of Local Affairs (DOLA) Affordable Housing Toolkit for Local Officials awarded BHA and its community partners a technical assistance grant that will offer expertise and resources from the DOLA Division of Housing and Enterprise Community Partners, over the next year.



The local Community Team will be led by BHA and include representatives from Broomfield FISH, Precious Child, Mental Health Partners, FRIENDS of Broomfield, Broomfield Resettlement Task Force, the Refuge, Broomfield Community

Foundation, Almost Home, City and County of Broomfield Division of Housing and Human Services, and other community agencies and faith-based organizations.

The grant will support the design and expansion of a robust and sustainable network of voucher/rental subsidy programs in Broomfield. The strategy will include identifying and pursuing vouchers and rental assistance resources (local, state and federal), nurturing landlord/property owner networks, and developing programming to support community members to ensure successful tenancy.
