When ordering trailers from SSCFW Trailers, we operate under the following guidelines:

The average waiting time for a trailer is 7 days. We have other orders to complete and we are filling them as fast as we can.

In order for us to hold a trailer for you, we ask that you pay a minimum deposit of 25% within 5 days from the date of the invoice, as a gesture of your intent to purchase.

You are welcome to pay a deposit, or the full amount, which ever suits you. If we receive your payment in full, your trailer will take priority.

Due to the timely nature of fitting items such as ladder racks, mesh ramps, mower boxes, toolboxes, cages, canvas covers, etc (if any), these items will not be fitted to your trailer until payment has been received in full.

If you change your mind regarding the purchase, your deposit will be refunded less \$150 or 6% of the total invoice (which-ever is the lesser amount) for restocking/administration/labour fee.

If no payment is received within 5 days, we retain the right to offer this trailer to the next customer.

If no payment is received within 10 days, and we have been unable to make contact with you, we will cancel your invoice.

If the trailer is to be registered in two names, both people need to be present at time of collection to sign the Application for Registration. If you are unable to collect your own trailer, the trailer will not be released until we have received the appropriate authority forms.

It is important to research your trailer requirements thoroughly. If you have a change of mind after taking delivery of your registered trailer, we are unable to issue a refund or exchange.
