



MUST ANSWER THE FOLLOWING QUESTIONS BEFORE RECEIVING FOOD:

- **ARE YOU A U.S. CITIZEN OR “QUALIFIED ALIEN”?**
- **HAVE YOU FILLED AN ELIGIBILITY FORM TO RECEIVE FOOD?**
 - New TEFAP clients must fill out an Eligibility Form.
- **ARE YOU STILL ELIGIBLE TO RECEIVE FOOD UNDER TEFAP?**
 - You are eligible if you receive any one of the following services:
 - Supplemental Nutrition Assistance Program (SNAP) (aka Food Stamps)
 - Temporary Assistance to Needy Families (TANF)
 - Supplemental Security Income (SSI)
 - Medicaid
 - OR, if your household income is at or below the income listed for the number of people in your household, you are eligible to receive food.
