Gift Aid

If you pay Income Tax and/or Capital Gains Tax, you can increase the value of your subscription and donations to the Merseyside Transport Trust by signing the Gift Aid declaration overleaf. This will be reclaimed from the Inland Revenue by the Merseyside Transport Trust (Charity No: 108974).

1. Please notify the Merseyside Transport Trust of any change of name or address
2. You may cancel the declaration at any time
3. You must pay an amount of UK Income Tax or Capital Gains Tax at least equal to the amount of tax the Merseyside Transport Trust reclaims on your donations in the tax year (currently 20p for each £1 which you give). If you pay less tax than will be claimed then it is your responsibility to pay HMRC the difference. If, in future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax, reclaimed by the Merseyside Transport Trust, you should cancel your declaration.
4. If you pay tax at the higher rate, you can claim further tax relief on your Self-Assessment form.
