Hello vendors, friends, and community,

The Sequim Irrigation Festival's long-running "Innovative Arts and Crafts Fair" has been officially renamed the "Creative Collective at Crazy Callen Weekend." This new name reflects the event's growing personality and its expanded offerings, celebrating not only handmade goods but a wider variety of creative, local, and small-business products. As the festival continues to evolve, the updated name better captures the energy, variety, and community spirit that make the weekend so special. The change also helps distinguish the fair within the larger festival lineup, giving it a fresh identity while honoring the tradition that has made it a beloved part of the Irrigation Festival for generations.

We invite you to submit an application for the 131st Sequim Irrigation Festival Creative Collective. We are happy to be at Carrie Blake Park in Sequim again this year. Our location allows all of the events happening this weekend to be closer together and also near the Food Court and all of the entertainment! This year's dates are May 2-3. The hours will be 9 AM – 5 PM on Saturday, and 11 AM- 5 PM on Sunday. The Sequim Irrigation Festival is a Family Friendly event. Our theme this year is "Let's Go Sequimming."

This year we have decided to accept vendors who embody all that Sequim has to offer. While the fair was once limited to handmade items only, we've expanded to welcome a broader range of creative, small-business, and artisan offerings that better reflect the diverse talents of our community. This is a juried show, and all submissions are judged on overall quality. To be a part of this year's event you simply need to fill out the application form and include your application fee. This year we are offering an "early" fee of only \$15 for applying before February 1. If you apply after this date the fee is \$25. Application fees are non-refundable. All applications must be submitted by March 15, 2026. Upon receipt of notification of acceptance not the show, your booth fee and proof of liability insurance will be due no later than April 15, 2026.

Please review the Vendor Guidelines carefully as some changes have been made. If you have any questions, please feel to reach out.

**Good Faith Pledge and Hold Harmless Waiver**

I, the Undersigned agree to adhere at all times to all rules, regulations and policies of the Sequim Irrigation Festival and to follow all directions and instructions of its officials, including its Security Personnel. The undersigned hereby releases the Sequim Irrigation Festival Committee of any care, custody or control against loss, theft, vandalism and/or fire during this event.

I, the Undersigned certify that I will only sell the type of items presented in this application.

I, the Undersigned do hereby agree to release, relieve, discharge, indemnify, defend and hold harmless the Sequim Irrigation Festival staff, all Sequim Irrigation Festival participants, the City of Sequim and their officers, agents, volunteers and employees, from all claims, losses, suits, damages, judgments, expenses, costs and charges of every kind, including court costs and attorney's fees, resulting from its occupancy of the space herein under contract by reason of personal injuries, death or property damages. The undersigned further agrees to indemnify, defend and hold harmless the Sequim Irrigation Festival staff, all Sequim Irrigation Festival participants, the City of Sequim, and their officers, agents, volunteers and employees, from any claims and for all damages, costs and expenses, including without limitation, court costs and attorney's fees and amounts paid in settlement incurred in connection with such claims arising out of acts of negligence of undersigned, his agents or employees. This paragraph shall survive termination of this Agreement.

I, the Undersigned fully understand that the terms of the Full Release shall serve as a Full Release and Full Assumption of risks for myself, my heirs, executors and administrators and for all persons authorized by me accompanying me to the Event.

I, the Undersigned understand that I am solely responsible for collecting and paying sales taxes on my goods and services for any and all business licenses necessary for doing business in the City of Sequim and the State of Washington.

The following is a summary of the guidelines associated with participating in the Sequim Irrigation Festival Creative Collective. Please review these guidelines prior to applying.

**Application Deadline:** Applications will be accepted until March 15, 2026. All applications must be complete and the Good Faith Pledge and Hold Harmless Waiver signed. Vendor Selection Process: This is a juried show. We present a wide variety of quality products to the public. The artist must provide proof of license in order to use trademarked images in their products. Vendors are monitored to ensure that the products sold reflect those presented in your application. We reserve the right to request that certain items be removed from sales or display if it violates our product requirements as stated above. Your application will not be juried until the application, images, Hold Harmless Agreement, and jury/application fee have been received. It is the Sequim Irrigation Festival Committee's discretion to accept or reject any applicant. The Sequim Irrigation Festival is a Family Friendly event and for that reason we cannot accept any booths that are considered discriminatory or offensive.

**Non-Profit Vendors:** We have limited space at a reduced cost for non-profit vendors. Please contact Dede Bessey at [innovativeac@irrigationfestival.com](mailto:innovativeac@irrigationfestival.com) for additional information on applying as a non-profit vendor.

**Application/Jury Fee:** A separate fee is required for your application to be considered. This is a non-refundable fee. The early application fee (submitted by February 1, 2026) is \$15. The late application fee is \$25.

**Booth Fee:** The booth fee for a 10'x10' booth is \$150, for a 10'x20' it is \$300. Some standard 120 power is available on a first come first serve basis. The cost for outlets is \$50. Please note that this is an outdoor event. We provide the space only; you must provide the materials that you require for your booth. This means a tent large enough for your booth AND weights; this also includes your tables/chairs, etc. After applying there will be NO REFUNDS of either application/jurying fee, nor booth fee.

**Hours of Operation:** All booths must be open for business Saturday, 9 am to 5 pm and Sunday, 11am- 5 pm. If you choose to break down early, you will not be accepted to the show again. If you arrive late, you will not be permitted to participate that day and you will not be issued a refund.

**Booth Setup:** A booth tent is required. Load-in will begin on Friday afternoon, May 1, 2026 from 1pm- 5pm. Load-in will also be available starting at 6am Saturday morning and must be completed by 8:30am. Friday afternoon is the only time that you can drive-up and unload next to your booth. Saturday you will not be allowed this luxury, as other event set-ups will be taking place, making drive up unloading impossible. Specific instructions for load-in and load-out will be sent to you with your booth location email in late April.

**Product and Booth Photos:** Submit at least three but not more than 6 print photos or digital images of your products and a photo of your booth. Photos will be kept on file by the festival and will not be returned. Items submitted to the jury must represent the different prices in your overall price range. Number and label your photos with your name and the item prices. The photos submitted by accepted vendors may be used by Sequim Irrigation Festival for marketing purposes. Photos must be included regardless of prior year(s) acceptance.

**Good Faith Pledge and Hold Harmless Waiver:** The Good Faith Pledge and Hold Harmless Waiver is required when you submit your application. It is NOT the same as the Certificate of Liability Insurance (discussed below) and does not take its place. Certificate of Liability Insurance: A copy of your Certificate of Insurance that names the Sequim Irrigation Festival as additional insured is required. This must be received by the festival by April 15th. If you do not have insurance, we encourage you to check out ACT insurance ([www.actinsurance.com](http://www.actinsurance.com)) for a one time show insurance. You will not be allowed to attend the show without this, and will not be refunded if you fail to provide.

**Booth Security:** Booths must be covered and able to withstand wind and rain. Booths may be left up overnight as there is a security patrol, but any merchandise should be secured and the festival is not responsible for loss or damage. "Blue tarps" are not allowed as booth shelters, but can be used to secure the booth at night.

**Booth Weights and Safety:** Sequim has a propensity for strong wind gusts, so in order to increase your safety and the safety of your neighbors, weights must be attached to each leg. Each leg of your canopy/tent must have 30 lbs. minimum weights attached.

You CANNOT stake your tent to the ground. We recommend that you add additional weights to your tent in case of high winds.

**Booth Fire Certification:** All tent/structure membranes, and all combustible decorative materials (sheers, curtains, draperies, flooring, tarps, blinds, etc.), shall be treated or constructed from a material that is flame resistant and has the appropriate label permanently attached to all sections of fabric. NFPA 701, CPAI 84, and California Fire Marshal Title 19 labels are accepted/approved. Tent structures will be examined by the Fire Marshall prior to the show opening to ensure they meet these standards. If you do not meet the Fire Marshall's standards you will NOT be allowed to participate and will not be issued a refund.

**Booth Take Down:** Your booth space must be left clean when you leave or you will not be invited back to future shows.

**Acceptance Notification:** Vendor notifications of acceptance will be sent as soon as your application has been through the jury/application review process. Your booth fee will be due at this time. You will receive additional information and booth location assignment late April.
