The goods and services shown below are those that we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic professional fee for services of funeral director and staff. If legal or other requirements mean that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

To Every Family That We Serve

One of the most important responsibilities that we have to each family we serve is to bring your emotional and financial needs together, whatever the situation may be. As part of our consultation with your family, we will discuss which different options we offer to help you with the funeral expenses. Our goal is to ensure that the services and merchandise you choose will fit into your financial situation. Payment arrangements must be discussed and made during the arrangement conference. Payment for all services, merchandise and cash advances are due in full by the day the funeral services are rendered.

THE USE OF AN INSURANCE ASSIGNMENT IS AT MANAGEMENT'S DISCRETION.

Life Insurance Policies are funded and advanced through a Third Party Processing Company. In most cases this can allow the funeral home and the beneficiary to receive insurance proceeds within 3 to 7 days from completion of the claim, subject to approval. The assignment fee is 4% added to the total assigned amount of the funeral contract. Note* Insurance Assignments require the following criteria:

- Original Insurance Policy
- Verification of the Beneficiary
- Verification that the policy is in force
- Verification that the policy is not contestable
- Verification that the policy is assignable to the funeral home
- Verification that there are enough funds to cover the funeral expenses

Insurance assignments may be acceptable if these criteria are met. If the certified death certificate is delayed for any reason, one of the other payment options presented must be in place. Your funeral director will discuss this in detail with you.

1. Basic Professional Fee for Services of Funeral Director and Staff\$ 2995

This fee for our basic services & overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, & forwarding or receiving remains.) The fee includes the following: Staff available 24 hours daily to respond to the initial request for services; Conference with the family or its representative & advice to determine desired services & to obtain vital statistical information for required documents; Securing obituary information; Sheltering of remains for 3 days; Coordinating the desired funeral service plans with: clergy, cemetery, crematory, and/or other third parties; Preparation & filing of all necessary notices, authorizations, & permits with governmental offices; and Follow-up attention to related details connected with the service. In addition, this fee includes a proportionate share of our basic overhead costs such as: Compliance with infectious waste management regulations & employee safety regulations mandated by governmental agencies; General administration & record keeping.

2. Transfer of Remains to the Funeral Home.

All transportation charges are for local service. Beyond a 45 mile radius add \$ 3.00 per loaded mile, per vehicle.

- A. Within a 45 mile radius of the funeral home \$ 400**
- B. Receiving remains at the funeral home with no transportation \$ 350**
- C. Additional staff for removal – per staff member..... \$ 150**

3. Embalming:

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

4. Other Preparation of Remains:

Forwarding Remains to Another Funeral Home \$ 2745
This charge includes: basic services of the funeral director, staff, overhead, local transfer of remains to our facility, embalming normal remains. **It does not include:** transportation to receiving funeral home/airport, merchandise, optional use of facilities, staff & equipment, the use of the facilities for, visitation, and/or a funeral ceremony, cosmetology, grooming & dressing, and/or other preparation of remains, if necessary.

Receiving Remains from Another Funeral Home \$ 1900
This charge includes: basic services of the funeral director, staff, overhead, local transportation of remains to place of final disposition. **It does not include:** transportation from forwarding funeral home/airport, merchandise, optional use of facilities, staff & equipment, the use of the facilities for, visitation, and/or a funeral ceremony, embalming, cosmetology & grooming, when receiving remains for viewing and/or other preparation of remains, if necessary.

Immediate Burial \$ 3795
This charge includes: basic services of the funeral director, staff, overhead, local transfer of remains to our facility, hearse (casket coach) for local transportation to cemetery. **It does not include:** merchandise, optional use of facilities, staff & equipment, the use of the facilities for visitation or a funeral ceremony, embalming & other preparation of remains, if necessary.

Direct Cremations \$ 3700

This charge includes: local transfer of the remains to our facility, basic services of the funeral director, staff and overhead, other preparation of remains for identification, service van for local transportation to and from crematory and Crematory fee. **It does not include:** merchandise, optional use of facilities, staff & equipment, the use of the facilities for visitation or a funeral ceremony, embalming & other preparation of remains, if necessary. Any cash advance items such as: death certificates, newspaper obituary, state or county permits. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials with or without an outside covering. The container we provide is a minimum cardboard cremation container.
