The Putnam County Board of Commissioners met on October 6, 2025, at 9:00 AM in regular session. The meeting was held at the Putnam County Courthouse. Woodall opened the meeting and the pledge to the flag was given.

Beck made the motion to add the coroner to the agenda. Helmer seconded. The motion passed unanimously.

HIGHWAY REPORT

Director Clint Maddox presented report:

- 1) Cornstalk bridge has new roof
- 2) Dunbar bridge getting painted
- 3) Bridge 191 is open as of 9/23 on CR 1000 S in Cloverdale Twp
- 4) Bridge 123 is open to local traffic
- 5) Bridge 124 under construction
- 6) Hydraulic study on Bridge 38 on CR 1000 N replace with pipe & Bridge 157 on CR 750 W replace with arch pipe. By replacing them with these pipes, it will remove them from the bridge inventory. It is the budget.
- 7) CR 250 E North of Roachdale traffic counter installed last Friday, see what results we get for speed limit sign.
- 8) Fuel tank replacement – met with companies. Waiting on quotes.
- 9) Working on community crossings grant application
- 10) Notice to bidders has been sent to the paper
- 11) Seeking quotes for grinder, no response yet
- 12) Fillmore Road, Beck said there is a section that needs to be filled in with rock.
- 13) Woodall asked about funding for rock and blacktop. Hughes said they were right on the budget.
- 14) Commissioners signed proposal for as needed professional engineering services with Fishbeck.

Helmer made the motion to adjourn. Beck seconded. The motion passed unanimously.



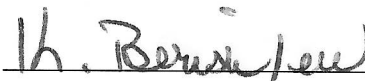
