

## **PUTNAM COUNTY PLAN COMMISSION MINUTES**

The Putnam County Plan Commission met for their regular meeting on June 9, 2025, at 5:30 p.m. in the Commissioner's Meeting of the Putnam County Courthouse 1 West Washington St, Greencastle, IN 46135. Kevin Scobee called the meeting to order at 5:30 p.m. A roll call was taken to determine a quorum. The following members were present: Kevin Scobee, Jenna Nees, Andy Beck, Zach Bowers, and James McKee. Jay Alcorn and Greg Williams were not present. Also, present were Jim Ensley, County Attorney, and Lisa Zeiner, Plan Director. Audience present see attached sign in sheet.

**REVIEW OF MINUTES:** March 10, 2025, and May 12, 2025.

Kevin Scobee asked if anyone had any additions or corrections to the minutes.

Andy Beck made a motion to approve March 10, 2025, and May 12, 2025, meeting minutes as presented.

Zach Bowers seconded the motion.

March 10, 2025, and May 12, 2025, minutes were approved as presented with all in favor.

### **OLD BUSINESS**

**2025-RZ-026: PAUL FAGIN** - Rezone from Rural Preservation (A1) to Residential (R1); Cloverdale Township; 12/12N/4W (located at 2152 E CR 1100 S; 67-16-12-200-002.001-002)

Lisa Zeiner explained that the petitioner could not attend the meeting but asked if I would present the project. Mrs. Zeiner stated that Rob with ASA is present to assist. Mrs. Zeiner explained that the project was on the south side of County Road 1100 South. Mrs. Zeiner stated that the properties to the east and north were already zoned residential. Mrs. Zeiner explained that the parcel has two primary dwellings on it and that because it is less than ten (10) acres, it could not be split in an A2 zone. Mrs. Zeiner stated that the purpose of the rezoning is so that the petitioner can split the parcel so that each dwelling would be on a separate lot. Mrs. Zeiner explained that the parcel has never been used as farm ground even though it is zoned agricultural.

Rob Costin, with ASA, approached the board. Mr. Costin stated that the parcel was 4.28 acres. Mr. Costin explained that it was part of what was originally known as Fagan Subdivision.

Mr. Scobee asked how long the second residence had been on the property.

Mrs. Zeiner stated that the second dwelling was built in 2015. Mrs. Zeiner explained that when the permit was issued it was for an addition to a pole barn. Mrs. Zeiner stated that the plans submitted did show a bathroom being added and they got a septic permit, but the plans did not actually show living quarters, just a bathroom and open areas that would be attached to the existing pole barn.

Mr. Scobee asked how the parcel would be split.

Mr. Costin showed a very rough sketch of the division line running between the two dwellings and showing the existing driveway would be shared.

Mrs. Zeiner stated that the plat process would have to go before the Technical Review committee for approval. Mrs. Zeiner explained that the Unified Development Ordinance allows for shared driveways or easements and that those are required to be shown on the plat that is recorded.

Mr. Scobee asked if there was anyone who wanted to speak for or against this project. No one came forward. Mr. Scobee closed the public hearing portion of the meeting.

Mr. Beck made a motion to recommend approval to the County Commissioners for the rezoning from A2 to R1 for **2025-RZ-026: PAUL FAGIN.**

Jenna Neese seconded the motion.

**2025-RZ-026: PAUL FAGIN** was remanded to the Putnam County Commissioners with a favorable recommendation to rezone from A2 to R1 with all in favor.

Mrs. Zeiner stated that this petition would go before the County Commissioners on June 16, 2025.

### **NEW BUSINESS**

**PUTNAM COUNTY REDEVELOPMENT COMMISSION:** Resolution developing an Economic Development Area to be Known as the Central Putnam Economic Development Area.

Kristen Clary, Executive Director of the Greencastle Putnam County Economic Development Office, approached the board. Ms. Clary described the plan to establish a tax increment finance (TIF) district to capture new tax revenue from industrial properties. Ms. Clary explained that the revenue would be used for improvements and development within the district. Ms. Clary stated that the goal was to focus on industrial growth while allowing residential and commercial growth tax revenues to continue to be distributed to existing taxing units. Ms. Clary explained that the boundaries of the proposed TIF district would stretch along a corridor in the county from Lone Star (Buzzi) to Poet. Ms. Clary clarified that the TIF district would capture any new assessed value resulting from capital infrastructure improvements made by industrial properties within the designated area. Ms. Clary explained that property taxes would continue to be distributed as normal. Ms. Clary stated that the County Council would decide how to spend the captured tax revenue. Ms. Clary explained that there were several designated taxpayers listed in the resolution, which include American Aggregates Corp, Carpenter Legacy Management, Eric Hayman, and others.

There was a brief discussion on tax abatements, assessing property values, and the percentage of tax to capture. Ms. Clary stated that the goal was to capture one hundred percent (100%) of the increase in tax revenues.


Zach Bowers made a motion to approve the Resolution to develop an economic development area.

**ORDER APPROVING

# **ECONOMIC DEVELOPMENT PLAN FOR THE CENTRAL PUTNAM ECONOMIC DEVELOPMENT AREA**

## **Putnam County Redevelopment Commission**

### **Purpose and Introduction**

This document is meant to serve as the Economic Development Plan (“Plan”) for the Putnam County Redevelopment Commission’s Central Putnam Economic Development Area (“Economic Development Area” or “EDA”) within Putnam County, Indiana. It is intended for approval by the Putnam County Commissioners, Putnam County Council, and the Putnam County Plan Commission in conformance with IC 36-7-14.

### **Project Objectives**

The purposes of the Plan are to benefit and protect the public health, safety, and welfare of the citizens of Putnam County; increase the economic well being of Putnam County and the State of Indiana; and serve to protect and increase property values within the County. The Plan is designed to create an environment which promotes opportunities for the gainful employment of the citizens of Putnam County, provide for local public improvements in the Economic Development Area, provide improvements of infrastructure which will encourage business expansion and attract new business enterprises to the Economic Development Area, avoid conditions which could negatively impact property values surrounding the Economic Development Area, attract and retain permanent jobs, increase the property tax base, and improve the diversity of the economic base of Putnam County.

The Findings of Fact Section of this Plan contains the supporting data for the above-declared purposes of the Plan.

### **Description of the Project Area**

The Economic Development Area is located in Putnam County and is described as that area contained in the property listings and maps and plats attached to this Plan. The general description is as follows: The area bound on the north by City of Greencastle south boundary north of Lone Star Industries/Buzzi Unicem, on the west by Manhattan Road, on the south by Town of Cloverdale north boundary south of Poet, and on the east by US 231, and commonly known as the Central Putnam TIF District.

### **Project Description**

The development of the Economic Development Area will proceed in phases as dictated by the Redevelopment Commission taking action when appropriate and necessary within its powers as allowed under IC 36-7-14.

The Redevelopment Commission initially proposes to establish and develop a Central Putnam Industrial Area by providing a funding mechanism to pay or reimburse the Putnam County Redevelopment Commission for infrastructure improvements in or serving the Central Putnam Industrial Area EDA. The Redevelopment Commission intends on capturing tax increment revenue from business and industrial development projects as they occur in the Central Putnam Industrial Area EDA to encourage further infrastructure development within the EDA and to reimburse the Redevelopment Commission for expenditures made in the future for infrastructure improvements within the EDA.

### **Acquisition of Property**

The Redevelopment Commission has no present plans to acquire any interest in real property within the Economic Development Area unless it is deemed necessary to meet the need of a given project. The Redevelopment Commission shall follow procedures in IC 36-7-14 in the event that it should acquire any property. The Redevelopment Commission may not exercise the power of eminent domain in an Economic Development Area.

### **Procedures with Respect to Projects**

In accomplishing any projects within the Economic Development Area, including any infrastructure improvements to the EDA's sewer and water systems, completion and expansion of any access road and parking areas, installation of necessary lighting and fire protection, or other economic development projects or infrastructure improvements within or serving the EDA (collectively the "Projects"), the Redevelopment Commission may proceed with the Projects before the acquisition of all interest in land in the Economic Development Area. As stated above, no property acquisition is currently contemplated as part of any project.

All contracts for material or labor in the accomplishment of the Projects funded by the Redevelopment Commission shall be let under IC 36-1.

In the planning and rezoning of real property acquired or to be acquired or to be used in the accomplishment of the Plan; the opening, closing, relocation, and improvements of public ways; and the construction, relocation, and improvement of sewers and utility services; the Redevelopment Commission shall proceed in the same manner as private owners of the property. The Redevelopment Commission may negotiate with property officers and agencies of the County to secure the proper orders, approvals, and consents.

Any construction work required in connection with any project in the Economic Development Area may be carried out as needed by the appropriate municipal or county department or agency. The Redevelopment Commission may carry out any construction work if all plans, specifications, and drawings are approved by the appropriate department or agency and the statutory

procedures for the letting of the contracts by the appropriate department or agency are followed by the Redevelopment Commission.

The Redevelopment Commission may pay any charges or assessments made on account of orders, approval, consents, and construction work with respect to the Projects or may agree to pay these assessments in installments as provided by statute in the case of private owners.

If acquisition is carried out by the Redevelopment Commission for the Projects, it may not be set aside for public ways, parking facilities, sewers, levees, parks, or other purposes until the Redevelopment Commission has obtained the consent and approval of the department or agency under whose jurisdiction the property will be placed.

### **Disposal of Property**

If acquisition of property by the Redevelopment Commission is required, the Redevelopment Commission may dispose of any such real property or lease to the public after causing to be prepared separate appraisals of the sale value or such real property value to be made by independent appraisers. However, if the real property is less than five acres in size and the fair market value of the real property or interest has been appraised by one independent appraiser at less than ten thousand dollars, the second appraisal may be made by a qualified employee of the County. The Redevelopment Commission will prepare an offering sheet and will maintain maps and plats showing size and location of all parcels to be offered. Notice will be published of any offering in accordance with IC 5-3-1. The Redevelopment Commission will follow the procedures of IC 36-7-14-22 in making a sale or lease of real property acquired.

### **Financing of the Projects**

It is the intention of the Redevelopment Commission to act as a conduit to utilize any and all forms of alternative financing available from the private sector and state and federal government sources as deemed necessary to support development within the Economic Development Area, which is consistent with objectives.

Furthermore, the Redevelopment Commission intends on utilizing captured incremental taxes to pay for economic development projects and infrastructure improvements within the EDA and to reimburse the Redevelopment Commission for any expenditures made to promote economic development within the EDA prior to the availability of incremental taxes from the EDA.

### **Special Development Considerations**

All facilities located within the Economic Development Area as designated in this document must be operated in a manner consistent with the regulations of the U.S. Environmental Protection Agency, the Indiana Department of Environmental Managements, the Indiana Department of Transportation, the

Putnam County Plan Commission, the Indiana State Building Commission, and the Putnam County Board of Health.

**Amendment of the Plan**

By following the procedures specified in IC 36-7-14-17.5, the Redevelopment Commission may amend the Plan for the Economic Development Area. However, any Redevelopment Commission financing of projects not included in this plan as approved, or enlargement of the boundaries of the Economic Development Area, must be approved by the Putnam County Commissioners, Putnam County Council, and the Putnam County Area Plan Commission.

**Cost Estimates**

Currently, there are no projects planned immediately within the proposed Economic Development Area and any development is to be provided from tax increment proceeds.

**Establishment of Redevelopment Commission**

This plan will be executed upon the approval of the Resolutions put forth to the Putnam County Commissioners, Putnam County Council, and Putnam County Plan Commission, and implemented now that the Putnam County Commissioners have established a Redevelopment Commission and have appointed members to this body.

**FACTUAL REPORT IN SUPPORT  
OF FINDINGS CONTAINED IN RESOLUTION NO 2025-1  
OF THE PUTNAM COUNTY REDEVELOPMENT COMMISSION**

1. The Plan for the Central Putnam Economic Development Area will aid in attracting new business enterprises to the Economic Development Area by providing for the necessary infrastructure improvements to entice and allow other businesses to locate in the Economic Development Area.
2. The planning, replanning, development and redevelopment of the Economic Development Area will benefit the public health, safety, morale and welfare, increase the economic well-being of the County and serve to protect and increase property values in the County through the attraction of new businesses to the EDA and by insuring that those new businesses are adequately served with public utilities and transportation.
3. The presence of all business enterprises in the Economic Development Area will greatly assist the County in their efforts to:
  - a. Reduce unemployment and underemployment among the citizens of the County;
  - b. Halt the out-migration of County residents seeking better employment opportunities;
  - c. Increase the overall economic well-being of the County;
  - d. Establish and continue the growth of the Central Putnam Industrial Area and serve as a springboard for further economic development throughout the County.
4. The Plan for the Economic Development Area cannot be achieved by regulatory processes or by the ordinary operation of private enterprise without resort to IC 36-7-14 (the redevelopment statute) because of the lack of local public improvements and the existence of conditions that lower the value of the land for development purposes. The Economic Development Area currently lacks the necessary public infrastructure improvements to accommodate the needs of industrial enterprises. There are no regulatory processes to produce these funds nor will private enterprise provide funds to make the necessary infrastructure improvements.

5. The accomplishment of the Plan for the Economic Development Area will be of public utility and benefit as measured by:
  - a. The attraction and retention of permanent jobs;
  - b. An increase in the property tax base;
  - c. Establishment, growth, and development of the Central Putnam Industrial Area.
  
6. The Commission estimates that it will fund improvements through a combination of capital investment with utilization of incremental tax revenues to reimburse the Commission for infrastructure improvements and/or fund additional economic development in or serving the Central Putnam Industrial Area Economic Development Area.
