Application Instructions

QLF PowerAid can be applied to all types of crops.

Maintenance Rate: Apply 1 to 2 quarts per acre.

Medium to Severe Deficiency Rate: Apply 3 to 4 quarts per acre.

Applications should be made at or prior to planting or at the start of the growing season. Applications should be made every 7 - 28 days as needed throughout the season.
