Our package charges for direct cremation include basic services of funeral director and staff, the local (within 15 miles) transfer of remains to the funeral home, the basic sheltering of the remains, the obtaining of necessary permits and authorizations, local transportation to the crematory, sanitary care, dressing, and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the cremation process, which is a crematory charge, or any other cash disbursement, or anything not expressly stated as being provided.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated fiberboard.

EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. "If you choose to have embalming performed, the decedent may be embalmed at a location other than this registered mortuary"

No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)
