Certificate of Insurance and City of Long Beach Itinerant License: Approved Vendors must provide a Certificate of Insurance to the DOG-O-RAMA Event Coordinator by August 18, 2026 prior to the event dates. The vendor agrees to

provide proof of insurance (a Certificate of Liability Insurance) for \$1,000,000. The Certificate of Liability must include the following additional insureds: City of Long Beach, Washington and its properties to include Veterans Field and Bolstad Beach Approach, Coastal Class Crepes/DOG-O-RAMA and it's officers. The vendor also agrees to provide proof of payment of the City of Long Beach Itinerant License. To purchase the Itinerant License, the vendor must contact Katie Metzger, City of Long Beach, at (360) 642-4421.
